Dear Arnella,

Re: Harold Robert Tant (ka Harry) - Date of Birth: 10/8/1958

Further to our initial telephone conversation on the 13th of November 2025, I have included a link in my email to Mr Tant's Barnardo's childcare records. The link will take you to OneDrive, where you can safely download and save the PDF files.

In accordance with the general Data Protection Regulations (GDPR) and the Data Protection Act (DPA) 2018, we are obliged to remove personal information that relates to third parties, such as personal and confidential information pertaining to Mr Tant's siblings, as well as personal information about other young people in the care of Barnardo's, removed from files. Where redactions are required in the records, under the above-mentioned legislation, I have deleted the text and inserted "*3rd Party information*", so Mr Tant know exactly what has been removed from his care records.

Arnella, when working directly with a care experienced person, I always explain, the records were not written with the expectation that they would ever read them, and words were not always chosen carefully or with sensitivity. The language used at the time the records were written is not what we would use now. Reading the records can often bring back memories and emotions from childhood, therefore the information might be upsetting to read. If Mr Tant has chosen to receive his records, I would be grateful if you can please pass this information to him, and he is welcome to contact me anytime in the future, if he would find it helpful to talk with us about the information in his records.

The original documents were copied onto microfilm and then printed off; therefore, those I am sharing are microfilm copies. Some pages might be very difficult to read due to the poor quality of the original document, but we have searched the microfilm for the best copies.


