We are in the process of gathering evidence and formulating your final Redress Scotland application. To finish this process there are a few things we need to confirm with you.

1. Has any of your contact information (phone number, email address, home address etc) changed since we had our initial call with you on 30/09/2025 ?
1. You have indicated that you wish to include a supporting statement in your application provided by your daughter Nicola Jackson. We will contact Nicola regarding the supporting statement using the contact information you have provided us with.
