I am writing further to your recent Data Subject Access Request on behalf of Mr Daniel John Day.

I am afraid that this will be a disappointing reply as although a through search has been made in our archived childrens records we can find no evidence that Mr Day was ever in the care of Barnardo's.

You say that your client was resident at Cruachan Children's Home. Barnardo's did have a home named Cruachan which opened as a diabetic unit in 1966 in the grounds of our Ravelrig home in Balerno. In 1973 the home changed to provide care for boys with physical or learning disabilities. Barnardo's closed Cruachan on 4 July 1986, some three years before your client was born. We believe that the home was later reopened as a childrens home and was run by Edinburgh Council, therefore we would suggest contacting them to see if they hold records relating to Mr Day's care.
