- Instruct a Debt Collection Agency to collect any outstanding amount, this will incur a further administration charge of **£31.50**
- If they can't contact you to discuss repayment options, they will carry out a **site welfare visit** at your home, which will allow them to assess your repayment options including the suitability of a Pay As You Go meter using one of the following options:
