Our client is a high priority application due to his age.

We can confirm our client does not have a terminal illness and has no relevant previous criminal convictions. You will note that the certified documents are signed by Matthew Reynard.

I will be sending a signed declaration 10 – Part 1 and a signed declaration 4 – Part 3 at a later date.

As explained by Mr McGarry in document, 3 this application will not be supported by a supporting statement as the only person the survivor discussed his experiences in care with was the local priest who has since passed away.
