SUBJECT ACCESS REQUEST

I write in response to your subject access request received on 2 March 2026.

Social Work records are held by the Authority who supervised the care and from where the client was taken in to care. In terms of Cardross Assessment Centre, although Cardross does fall within the Argyll and Bute area now, historically, this would have been under Strathclyde Regional Council and subsequently West Dunbartonshire took over Cardross Assessment Centre. Again, any records are likely to be held by the placing authority. I note from your request that Mr Burrows was taken in to care from the Dumbarton area, therefore records would be held by West Dunbartonshire Council. With regards to Blairvadach House this was run by Glasgow Burgh Council and records will be held at Glasgow City Council if not held by placing authority.

I am sorry that we have been unable to locate any records for Mr Burrows and would recommend that a Subject Access Request is made to West Dunbartonshire and Glasgow City Council who may be able to assist.

Should you have any concerns about the information provided to you, I would be grateful if you could contact me to discuss this in the first instance.
