- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I told my guidance teacher what was happening at home, I did not return to live with my mum. Instead, I was placed in foster care with the family of one of my friends. Although my foster carer did many things that I now believe were wrong, one thing she did do was try to protect me from becoming pregnant while I was still underage. She recognised that I was still a child and understood that becoming pregnant would force me to grow up before I was ready and take away my innocence.

At the time, I was in a relationship with my children's father. He would come to the house, throw stones at my bedroom window, and I would sneak out to see him. My foster carer tried everything she could to stop this from happening, but she realised she could no longer keep me safe. She contacted social work and explained that I needed more protection because she was worried I would become pregnant while I was still a child. Those concerns were the reason I was removed from her care and placed back into a children's home. She was asking the professionals to protect me when she could no longer do so herself.
