- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When moving to Polmont it was a similar experience as Glenochil in terms of being thrown in to your cell by the staff members. They also used to shout in my face and grab me by the shoulder. If you was caught talking in your dorm and caught by the staff members I'd again be sleep deprived by being made to stand outside my dorm for 2-3 hours in complete silence. If you was caught again you was put in the 'Digger' which is an isolated room with just a chair and a table, no bed, so you could not lie down unless it was on the floor and that would be for a few days. The food was also non-nutritional and I remember being constantly hungry here. If I'd of missed collecting my food there was never a 2nd chance of going to collect it so you then had to do without.
