During the first foster care placement I was in significant emotional distress. I was abused by my older brother multiple times. He would touch me, have intercourse with me and he also took many naked pictures of me. I was wetting the bed all the time, but instead of anyone asking why or recognising that this could have been a sign that something was wrong, I was simply punished for it. Looking back, I believe this was a reaction to the abuse I was experiencing. They looked after us to a certain extent, but I felt abandoned. They missed the signs that I was being abused and paid no attention to the changes in my behaviour. There was a lack of supervision, awareness and attention, and nobody questioned why I was showing these signs of distress. I do not feel that they recognised what was happening to me or took steps to protect me. It was only after the photographs my brother had taken were discovered that the abuse came to light. Following this, my siblings and I were removed from their care and placed into another.

The carers in this home were highly abusive. I made a number of complaints about them, and reports were made regarding their behaviour, but to my knowledge they are still approved foster carers. My brother reported that they had hit him with a pole. Following that allegation, my brother was moved from the placement. Despite this, I remained in the foster home. The abuse I experienced was mainly emotional and psychological. They used food as a form of punishment and control. They regularly called me degrading names, including "slut" and "whore". They tried to control every aspect of my life, including what I wore, whether I could wear make-up, how I styled my hair, and whether I could speak to boys. I was not allowed to leave the school grounds during breaks, in case of any communication with boys. The foster carers also failed to dress me properly, sexualising me, I was only a child. It was constant coercive and controlling behaviour. I felt as though I was treated as an object rather than a child, and that I was there for the money and to be controlled. There was one occasion where I believed the abuse was about to become physical, but the foster carers' son walked in and interrupted what was happening. I know that another young boy in the same foster home was also abused. Reports were made about his treatment as well, but, as far as I am aware, nothing was done.

During my time in this placement, I began to develop significant mental health difficulties. I struggled with depression, anxiety, self-harm, and suicidal thoughts. Eventually, following further reports and concerns, I was moved from the placement. Despite the number of complaints and reports made by me and others, I understand that these foster carers continued to foster children. I found this extremely difficult, particularly knowing that concerns had been raised repeatedly but no effective action appeared to have been taken.

I was taken to another foster care setting after this. I was groomed by an adult male who was over the age of 18 and lived in the same village. My foster carer reported concerns about my wellbeing to my social worker. She was worried and that I was at risk. Despite these concerns being raised, I do not feel that my social worker took the situation seriously. Instead of recognising the risk I was in, they were very welcoming towards him. It felt to me as though they may as well have invited him to dinner. It felt as though they accepted him instead of protecting me. The man who groomed me, and his friends, also supplied me with illegal substances, which increased my vulnerability. I was a child forced into having sex with someone older than 18, in public spaces. This was not okay. In the end, my foster carer said that she could not keep me safe and asked for me to be moved. The decision to move me was made because my foster carer felt she could no longer protect me, not because my social worker chose to remove me or took action to keep me safe. I believe that, despite concerns being reported, there was a failure to take appropriate action to safeguard me.

I have been left with trauma and severe mental health issues. The PTSD caused flashbacks which effects my life. As an adult I started working for social services in an attempt to fix the mess that caused my childhood to be ruined. To this day it is still not good enough.
