- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

I remember one time I was playing on the PlayStation as I thought I was allowed to and one of the other kids come in and beat me up for it.

I was bullied quite a lot here by these kids and it made my experience horrible for me.
