- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

You can continue on additional pages if you need to.

Your statement for additional care settings

I was then moved to another temporary foster care and here I was still 6-7 years old.

Again I wasn't looked after here, my clothes were never clean and I was neglected of an education as I never attended a school.

These foster parents used to drink alcohol and I witnessed this as a young kid, they also used to allow me to drink too.

The only clothes I had was the clothes from my mums, nothing was ever bought for me and as I described, these clothes were never kept fresh or clean.
