At the children's hearing the child or his parents may or may not accept the grounds for bringing the child before the hearing. If the grounds are accepted by the child, and his parents, if present, the children's hearing will discuss and consider with the child and his parents what is best for the child. If any of the grounds are not accepted, the hearing may either discharge the referral or direct the reporter to apply to the sheriff for a decision as to whether or not any of the grounds exist. If this happens the child will have to appear before the sheriff at a later date. If the sheriff decides that any of the grounds do exist, the children's hearing will then discuss and consider what is best for the child, as if these grounds had been accepted. If the sheriff decides that no grounds exist the referral will be discharged.

ANDREW McCracken

Andy was returned from police custody by his Local Authority Social Worker yesterday afternoon. He was spoken to by [redacted] his key worker within Geilsland. [redacted] spoke with Andy in the evening last night when Andy seemed pretty settled. About 8.45pm, word was received that he was missing from the New Vic House Unit. [redacted] Engineering Instructor, who was on duty within the New Vic House Unit and [redacted] made a local search of the town and caught up with Andy in the Dalry Road, Beith. Andy offered no resistance and came into the car quite willingly. He did state that he wasn't going to stay in the school but was wanting to make his way back to the Coatbridge/Airdrie area. On returning to the school, [redacted] spent some time with him in the Headmaster's Office and went through the incidents which led to Andy being charged yesterday. Andrew states the first incident of fire-raising happened about 5 weeks ago. He, along with his co-accused, [redacted] broke into an E-registration Mercedes van owned by [redacted], Andrew breaking the window and because he had gloves on, opened the door, and according to Andrew, the [redacted] set fire to the van. The second incident transpired about a week after that when another van a W-registration, was broken into and also set alight. The third and most disturbing incident happened the weekend prior to Andrew going on Christmas and New Year leave and again in company of the [redacted] on the premises of Coatbridge and Cumbernauld Technical Association. Their offices were broken into at the back of the premises, methalated spirits in a plastic container splashed all over the place and then the place set alight. According to Andrew, the place was gutted. [redacted] stated to Andrew that he was in what could be very serious trouble and asked how the police had come to charge him with these incidents yesterday. Andrew states that after the police had picked him up, they took him to the office where his fingerprints were taken and he was subsequently charged. [redacted] asked how they had evidence to this and Andrew stated that the second van which was set alight had Andrew's fingerprints from the back door of the van. Concern was expressed to Andrew about his association with the [redacted] because it was in this boy's company that Andrew had previously been charged with being in possession of butcher's knives. The boy [redacted] having broken into the butcher's shop and stolen the knives. [redacted] enquired from Andrew where he would have stayed if we hadn't been able to apprehend him tonight. He stated that he would have stayed with a cousin in Coatbridge. [redacted] pointed out the serious offence which the cousin could be charged with namely harbouring if Andrew had made it to Coatbridge and if the police had caught Andrew within the cousin's home. Andrew still seemed agitated at this time and we were joined by [redacted] who also expressed concern, regret and hurt at Andrew's actions earlier on this evening. Andrew also handed over to [redacted] £8 which he had in his possession which [redacted] duly entered into the boy's own account within the school. Andrew felt it would be hard for him to remain within the school for two or three weekends to allow both [redacted] and the Local Authority Social Worker, [redacted] to have some liaison with the police regarding the outstanding offences which they have against Andrew. [redacted] also pointed out to Andrew that it was [redacted] intention which Andrew had already known about, but which [redacted] felt he had to reinforce namely that next week [redacted] will be taking Andrew home on a supervised visit and also this to continue the following weekend. [redacted]

Andrew himself acknowledged the fact that if he was in his home area, then he could be at risk from the police. [redacted] according to Andrew, at any time the [redacted] appeared at her home, ordered the boy out and told him not to come back and see Andrew, but unfortunately prior to these incidents, Andrew had met up with the [redacted] in Glasgow and the subsequent events have already been dictated. Andrew did give [redacted] his assurance that if he felt like absconding again, he would talk it over with a member of staff. Andrew was then taken over to the New Vic unit by [redacted] and got ready for his bed. [redacted]

Significant Past Events

Prior to Andrew's admission to Newfield he was resident at his maternal grandmother's home at 50 Oxford Street Coatbridge. This arrangement has been going on since Andrew was a baby. It would appear that Mrs Craig (grandmother) has brought Andrew up rather as a son. However, over the last few years the relationship has changed in that Andrew has increasingly had to look after Mrs Craig as she has become progressively frail.

Family View of Problem Areas

Mrs McCracken was very defensive when it came to discussing Andrew's difficulties. She seemed to indicate that it had all been a bit of an injustice that Andrew had been "taken away" from his grandmother. She outlined the history surrounding Andrew living with her mother rather than in the family home. It appears that Mrs Craig for what ever reason felt closer to Andrew than perhaps was Mrs McCracken. Mrs McCracken feels that little blame can be attributed to Mrs Craig for Andrew's lack of school attendance as it appears Mrs Craig was putting Andrew out to school in the morning. She also pointed out that at a Children's Hearing in May of last

year a Supervision Order was made out with a condition that Andrew was to reside with his Grandmother.

It would appear that Mrs McCracken was a frequent visitor to her mother's house but she had little influence with Andrew as regards his truancy. Mrs McCracken has strong feelings regarding Rosehall High. She feels that there is a great deal of bullying going on and Andrew on occasion has been subjected to taunts because she is a single parent and the circumstances surrounding his place of residence.

Child and Family Relationships

As afore-mentioned Andrew does not live at home. Mrs McCracken does make frequent visits to her mother's house [REDACTED]

[REDACTED] It is fairly obvious that Mrs Craig has been dependent on Andrew for help over the last year or two as her health has declined. It would seem that Andrew has not spent much time in the home with Mrs McCracken and there is little between Andrew and [REDACTED]

[REDACTED] Observations at Newfield indicate that Andrew has a fairly normal relationship with his brother. As far as Andrew and his sisters are concerned he appears to have fairly positive feelings for them.

It would appear that there would be no benefit achieved in Andrew returning to stay with his Grandmother. As far as Mrs McCracken is concerned it is unlikely that after all these years away from the home that a return would bring any significant improvement in Andrew's school attendance or indeed an improvement in his general standard of care.

Andrew is fairly honest and realistic when he says that he will not return to Rosehall High. He is somewhat reticent when the possibility of returning to his mother's is discussed.

Observations from staff in Newfield indicate that Andrew has been somewhat relieved to receive a reasonable standard of care and appears to have benefited from the residential experience. It may be that Andrew would benefit from a further period perhaps in a Children's Home where he could get back into the habit of attending school as a result of the appropriate guidance and attention he would receive from staff.

RESIDENTIAL ASSESSMENT REPORT

Andrew was admitted to Newfield House, Gleniffer Unit, on the 6th March 1987 under Section 43(4) and 40(7) of the Social Work (Scotland) Act 1968.

He was accompanied by his mother and Social Worker. Andrew was quiet and seemed very tense. His appearance was dirty and dishevelled and he did not appear to be very well cared for at all. Andrew had a bath then made up his bed.

In the early part of the evening he seemed to be quite shy and subdued, however, he accepted an invitation from one of the other boys to have a game of pool. Later he ate his supper then settled to watch television. At bedtime he seemed to adjust quickly to the dormitory situation and was helped by one of the other boys to remake his bed because his duvet cover had not been put on properly. He appeared to find no difficulty settling. Staff observations indicate he slept well during the night.

Relationships and Interactions with Peers

Initially, Andrew appeared to find difficulty relating to his peers. He seemed to be shy and quite embarrassed. However, during his stay he has made quite a few meaningful relationships with both male and female peers. Although Andrew is quiet he interacts positively when on group outings and participates in all Unit activities, eg pool, darts and board games. When other children display unacceptable behaviour Andrew will steer clear and make himself scarce or will just sit quietly and be uninvolved in the situation. He appears to be accepted and well-liked by both male and female peers.

Relationships and Interactions with Staff

Andrew's interactions with staff appear to be positive. He seems to enjoy staff attention although he does not seek it. He is always polite and pleasant in his attitude towards both male and female members of staff. He appears to have a positive relationship with all members of staff.

Response to Rules and Management of Behaviour

Andrew's behaviour has presented no management problems. During his stay in Newfield he has complied with rules and routines without question. In my opinion Andrew is not anti-authoritarian, he responds positively to staff request eg help with Unit chores, bedtimes, bath and smoking times etc. Observations show Andrew has presented no behavioural problems at all.

Assessment of Social Skills

Andrew initially needed guidance in caring for his personal hygiene and general appearance. He now needs no reminders to bathe, comb his hair or put his dirty washing out for laundry. He presents as a pleasant likeable boy who does not lack social graces. He is polite and mannerable, kind and always shares his sweets etc with the other children.

Andrew is quiet, but when spoken to will converse quite freely, his facial expressions being appropriate. He has quite a few interests and hobbies. He likes Woodwork and Art within the school. His regular pastimes are pool and board games, namely Risk. His concentration span is quite long.

As highlighted earlier Andrew is quiet but his skills in forming relationships are good.

30/9/86: Childrens Hearing changed 44(G) Care
requirement instructing Andrew to reside
with his mother at 196 Whifflet St. In
conjunction with E. Muncroff (S.S.W.), a decision
was made that standards within his
grandmother's home were so appalling that
Andrew could not be allowed to stay there.

This will cause Andrew a great deal of
difficulty since he has resided with his
granny since birth. He is obsessed with
his granny but also gains financially from
this arrangement (e.g. pocket-money £10-£15 per
week). Glue Mrs Craig should be in
residential care (84 yrs) but despite all
my efforts she will not allow the S.W.D
to assist her.

Accordingly Andrew lives in
appalling conditions and decides every
aspect of his life for himself. He is a total
stranger to rules and regulations.

I am
conscious that we will face the gravest
of difficulties trying to implement this

only. Andrew is not an arrogant boy but he simply cannot understand what all the fuss is about. He has no meaningful relationship with any adult other than his grandmother. In many ways he is developing an eccentric image and at school he is nick-named "STUPID".

Mrs Mc Cracken

has no control over Andrew. Hardly surprising since she has had little involvement in his parenting. There is no stability in Andrew's life and Mrs Mc Cracken is so unstable that she will be unable to cope with Andrew.

October '86 - December '86

Every effort has been made to try to supervise Andrew. However he refuses to leave his grandmother and neither will he attend school. I have tried every approach to supervision but I am afraid that we are getting "no change" out of Andrew. He cannot accept authority since he has never been exposed to this.

He shows signs of maladjustment in his distrust and inability to form or sustain relationships.

On the few occasions on which he has attended for supervision he can only smile when the implications of his behaviour are pointed out to him.

I also tried to have Andrew attend residentially at Bowryhill but he refuses to go. Slowly but surely

I am preparing Andrew & Mrs McCracken for the inevitability that he will attend up initially in either Newfield or Crowthorn.

January '87: Andrew has not gone back to school and I did not expect him to do so. The wheels are now in motion to Review the case at a Hearing and I am looking for a 3 week assessment period.

I have discussed the case with
[redacted] (S.S.W) who ~~agrees~~ agrees
with these proposals.

6/2/87: Meeting with [redacted] (District
Officer) Child Care.

It was fully agreed
that the case be presented to Regional
Screening Panel for consideration of
residential assessment.

16/2/87: Regional Screening Panel:

Residential
assessment panel agreed. Serious problem
about lack of beds in either Wewford
or Conners. After endless negotiation a
bed became available in Wewford.

6/3/87: Childrens Hearing:

Andrew was admitted
to Wewford under warrant and presented
no difficulty on admission.

He presented
residential staff with no management
difficulties during his stay. Indeed it

was felt that in a strange way he seemed to be relieved to be in a caring and structured environment. There has been a significant change in his personal appearance due to regular shaving and clean clothes.

However Andrew still cannot contemplate leaving his granny and is making it clear that he will not reside with his mother. Mrs McCracken has been visiting and given financial assistance to travel by S.W.D.

A lengthy formal assessment meeting came to the unanimous conclusion that Andrew required further residential care within a Childrens Home setting. Mrs McCracken exploded at the meeting but eventually reluctantly accepted this proposal.

I am now looking for a place for Andrew in a Childrens Home.

26/3/87: Childrens Hearing: Warrant continued
to allow time to find place for Andrew.

A place became available at Mitchell
St. Re-admission visit was held and
attended by Andrew & Mrs Mc Cracken.

Contract: 1) ~~to~~ Andrew to obey Mitchell St
house rules.

2) Andrew to attend school
every day.

3). Weekly supervision by
welfare.

4) Andrew will be allowed to
visit his mother and granny.

5) Work to be carried out to
prepare Andrew for a return to live
with his mother but not his
granny.

Andrew also spent a day at Mitchell St
to make him self familiar with the
Home, the staff and other ~~see~~ children.
He also went to the bath's that day.

15/4/87: Childrens Hearing: Andrew named the
Subject of a GLE (i) Co) at Mitchell St.
Andrew will not have to attend school
for 1 week due to the Easter Holidays
and this should allow him time to
settle.

21/4/87: Andrew taken to school by member of
Staff from Mitchell St.

29/4/87: A number of problems are cropping up.
Andrew has missed 2 1/2 days schooling.
Spent his time allegedly walking about
whiffled but I will say just that he
has been between his gran's and
his mother's.

29/4/87: Meeting at Rosehall High School:
Teachers

Concerned about Andrew's lack of
commitment to attending school. He
says that he does not know whether

or not he will attend any school. Mrs
McCracken ~~was~~ initially was blaming the problem
on bullying but eventually realised that
the school were not to blame. She threatened
to assault Andrew who faced up to his
mother saying that he would strike
her back.

Rosehall are willing to
continue to try but obviously can
only take so much. Andrew could
be either suspended or expelled. The
following agreement has now been
drawn up although I have little
faith in working.

- 1) Andrew to attend school every
day
- 2) Andrew only to visit his
gran and mother on TUESDAYS
& THURSDAYS.
- 3) If Andrew alleges illness he will
see the school nurse. If she
sends him from school he will

return to Mitchell St and not his
Granny's.

Assessment: Presently I do not see this
case working out. If Andrew fails to
attend school a crisis will be reached.
He would have to move from Mitchell
St. However he is clearly not
best (D) maternal. We would therefore
be looking for special educational
provision through Child Guidance.
However Education only have 5 day
a week residential provision and
we would still need a place on
a childrens home at week-ends.
There is no way that I would
consider returning Andrew home at
week-ends to simply do as he
pleased. He would simply live with
his granny. He refuses to live with his
mother who could not cope with
him anyway.

Andrew appeared at a Hearing on 6.5.86 when a Section 44(1)(a) Supervision Order was imposed following grounds of truancy. A condition was inserted that he be allowed to continue to reside with his 82 year old grandmother despite grave reservations about her level of frailty and infirmity, coupled with unhygienic home living conditions. [REDACTED]

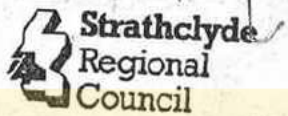
The writer has attempted to supervise this case but has encountered a variety of difficulties.

- 1) Mrs Craig is hardly capable of looking after herself, far less Andrew. She is almost deaf and communication is almost impossible.
- 2) Andrew cares for Mrs Craig and this does not help his school attendance record.
- 3) Home conditions are extremely poor to the extent that the writer does not consider that it is a suitable environment in which a child should live.
- 4) Mrs McCracken, Andrew's mother, is an extremely volatile and neurotic woman who all too easily 'flies off the handle' if questioned about the situation.
- 5) Andrew has failed to keep social work appointments with the writer.
- 6) The school allege that Andrew has been absent for almost three weeks.

ASSESSMENT:

The writer is clearly of the opinion that Andrew must return to live with his mother. Given old Mrs Craig's age and condition, he would have to return to his mother at some point. Andrew has reached the stage where, through his enjoyment of an independent lifestyle, school has become an unnecessary burden for him. Mrs McCracken has agreed that Andrew should now live with her but given her personality and volatile disposition, this opinion could change overnight. [REDACTED]

However at this stage, despite the continued truancy problem and lack of co-operation from Andrew, the writer would suggest that he be given an opportunity to prove that he will attend school if living with his mother. Concerns must be expressed meanwhile about the longer term developments.
