Your statement for additional care settings

I told social work that my stepdad was physically abusing my mum. However, because he worked for the police, I felt that nothing was done about what I had reported and that the situation was simply ignored. Instead, I was labelled as “unruly” and was taken into care along with my siblings. My behaviour at the time was a result of what I had witnessed and experienced at home, but no one ever seemed to look into the reasons behind it or consider the effect the situation was having on me.

At the time, I attended school in Helensburgh. Despite this, I was placed in a children’s home approximately 40 miles away from my school. At a very young age, I was expected to make this long commute every day so that I could continue attending school.

While I was living in this placement, I took an overdose and was taken to hospital. I was only 14 years old. I was placed on a ward with elderly patients rather than somewhere that I felt was appropriate for a child in such distress.

I eventually ran away from the hospital during the night. I remember being outside alone, walking along a long road in the pitch black. The police eventually found me and took me back to the hospital. As far as I can remember, no one questioned why a 14-year-old child who had just taken an overdose had then run away from hospital, or properly investigated what was happening in my life that had led me to that point.

After I had been in the care placement for nearly a year, my sister took me out and I went to live with her. However, she later got into trouble and blamed me for what had happened. As a result, she sent me back into care.

Throughout this period, I experienced repeated instability and distress, but I do not remember anyone properly looking into the circumstances at home, what I had witnessed, or why I was struggling. Instead, my behaviour appeared to be treated as the problem, without anyone addressing what had caused that behaviour in the first place.
