- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Supportive Accommodation

I was sent here when I turned 16. I was basically thrown out and left to fend for myself. I was kicked out of here because I was constantly getting trouble. I was too much and they got rid of me. I ran away to England to see my brother. Ever since I have never been able to settle. I became self destructive since I left care, and have been that way ever since. The experiences I went through have had a profound and lasting impact on my life. I suffer from severe PTSD and depressive disorder. I experience distressing flashbacks in my dreams and often wake up terrified, in an extreme state of anxiety, feeling as though I am reliving what happened to me.

My life has been filled with struggles as a result of my childhood experiences. I find it extremely difficult to maintain relationships and often push people away. I also struggle to recognise and understand my own emotions, and I find it hard to differentiate what I am feeling. This has affected every aspect of my life, making it difficult to trust others, form close connections, and cope with everyday situations.
