- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

My time in Foster care started off well at first. Until things started to be different. Me and my foster brothers become really close. I didn't see much of my Foster dad as he was always working. My Foster mum was also lovely too!

I had foster siblings ages 10,11 and 14.

I suffered sexual abuse here by my foster dad. I asked him for shoes for work experiencing that I was starting and he said to me "to get the money you have to do something for me" when I questioned what, he put his hands up my shorts and touched me. He was happy with what he was doing and because he got what he wanted, he give me £20.

What I learnt then about my Foster dad was that he was not one to be messed with, he was very intimidating.

The second occasion happened when I was jumped on the bus on the way back to my foster home. Later that night, I was watching TV and I was in a lot of pain, everybody was in bed and my foster dad came in and he raped me. I was in a terrible state for what happened. This really did mentally mess with me.

The names of my foster parents were - Helen Ross (Mum) James (Jim) Ross (Dad)
