Additional Information

Data Controller

The controller of your personal data is the Scottish Prison Service, Calton House, 5 Redheughs Rigg, Edinburgh, EH12 9HW. SPS acts on behalf of the Scottish Ministers.

Data Protection Officer

The SPS Data Protection Officer (DPO) is the Head of Information Management who can be contacted at the above address.

What We Do With Your Personal Data

Your personal data is managed in a secure manner and only SPS employees or partners working with SPS with a need to see the information have access to it. The information we hold is used in a range of ways including, where appropriate:

- Sentence calculations; supervision level; discipline; communications or complaints from you; managing your care; support from partner organisations; consideration for parole; dealing with courts and/or legal representatives; providing continuity of support services when you leave custody; public health; research.

It is likely that we will share your data, where there is a legal basis to do so, with some or all of the following:-

- Scottish Government; Scottish Courts & Tribunals Service; Crown Office & Procurator Fiscals Service; Parole Board; Police Scotland; UK Security Services; HM Revenue & Customs; Department for Work & Pensions; Social Security Scotland; Home Office: Immigration Enforcement; Local Authorities including Social Work and Housing; Registered Social Landlords; National Health Service; NHS Test and Protect; Audit Scotland; Auditor General; Accounts Commission.

Legal Basis for Processing Personal Data

SPS processes your personal data for one or more of the law enforcement purposes in line with the Data Protection Act 2018 Part 3: Law Enforcement Processing. The law enforcement purposes are the prevention, investigation, detection or prosecution of criminal offences or the execution of criminal penalties, including the safeguarding against and the prevention of threats to public security.

If the processing is sensitive processing then the legal basis is for a law enforcement purpose; to exercise a function conferred on SPS by an enactment or rule of law; or for reasons of substantial public interest.

In the majority of circumstances the SPS does not require your permission to process your personal data. Where processing of your personal data is based upon consent you may withdraw that consent at any time.

How Long Do We Keep Your Personal Data

We only retain your personal data for as long as is necessary. The timeframes differ depending on the type of personal data being processed and the retention and destruction policies specified by SPS.

What Are Your Rights?

- **Access to Personal Data** - You can request to see the personal data that SPS is processing about you.
- **Rectification of Personal Data** - If you believe the personal data that SPS is processing about you is incorrect then you are entitled to request to have that data corrected.
- **Erasure of Personal Data or the Restriction of its Processing** - You have the right to ask for your personal data to be erased or to restrict processing of that data. Please note that this right is unlikely to apply where it is still necessary for SPS to process your data for the purposes for which it was collected.

Requests should be made in writing to prison staff.

If you are not satisfied with the response you may contact the SPS Data Protection Officer at SPS headquarters (see address above).
