Your statement for additional care settings

I was a very young boy when being placed here.
I find it a very weird experience to have had at a young age.

I didn't get on well with the staff members here and that was just a natural vibe from it all. I was physically restrained on multiple occasions here by the staff members in which they caused physical pain to me. At a young age this was hard to contain. A fight broke out between me and another boy and the teachers restrained me and when doing so, a teacher called "Mr. Harris" he dislocated both of my knee's from bad manhandling me. He knelt on my knee to restrain me and when I've stood up with my hands still restrained I've reacted in pain and as a result of that, I've been pulled back to the floor and then my other knee dislocated.

I was made to stay in school the rest of the day whilst my knee's were getting more swollen. Mr. Harris then took my home and said for my mum to take me to the hospital. Mr. Harris admitted he didn't want the school to get a bad reputation and that's the reason why I wasn't taken to the hospital sooner.
