Your statement for additional care settings

When being placed in this YOI, this was a complete different setting for myself. This was a very territorial place. The boys in here knew where I was from and purposely abuse me by standing on my toes, pushing and humiliating me whilst laughing at me along the way.

The guards here were very degrading to myself and I never had anybody to turn to or even speak to on how I was feeling. I was very lucky to have my brother with me in my cell but we ended up getting separated which I then felt the isolation when he was gone.

I felt like I was a nobody. Waking up everyday not knowing what would happen to me or what somebody would come and do.

My food was teased with in this facility and I would sometimes not receive as the guards would say i'd been naughty when I hadn't just because they felt like they had power to do so. Even when I was actually good I'd still be rejected of food.
