- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was told I was sent here so they could find out if I should be sent to a care home or a borstal.

Daily life there was horrible. I remember being locked in cupboards quite often, and at the time, this seemed like a normal part of daily life there. The staff were rough with us when they put us in the cupboard. They would throw us inside, even though the cupboard was tiny. While we were locked in there, we would miss meals. I also remember being left in the cupboard overnight on a few occasions.

The staff were also verbally abusive. They would tell me that I was worthless and that the only reason I was there was because I was bad. They told me that I would never amount to anything, that I would end up in prison, and that prison was the best place for me.

If we became unruly or spoke back, the staff would lock us in a room they called the "playroom" and allow the other children to beat us up. The staff encouraged this behaviour. I also witnessed staff physically hitting other children on several occasions.

I remember feeling scared while I was there. More than anything, I remember how much I hated being there.
