- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was at Kerelaw for approximately six or seven months. During my time there, I regularly witnessed people being restrained and hit. On a day-to-day basis, I remember hearing people screaming and being hurt. It was while I was at the residential school that I experienced serious abuse myself.

There was one teacher in particular, the art teacher, who behaved inappropriately towards me and other boys. He would deliberately brush past us and touch us inappropriately. On occasions, he would touch and feel me around my private areas. This made me feel extremely uncomfortable.

He would threaten us and tell us not to tell anyone what he was doing. He said that if we spoke about it, he would punish us. At the time, I was scared of what that punishment might involve because of the way he behaved towards us on a daily basis.

I was also too embarrassed and humiliated to tell anyone what was happening. As a young boy, I felt ashamed and frightened about speaking up.

I remember one occasion when the art teacher tried to touch me inappropriately and I pulled away from him. When I did this, he slapped me. I felt that we had to accept what he did to us because if we resisted him, he would become physically violent. There were other people who witnessed some of this behaviour, including the occasion when I was slapped. However, at the time, this type of treatment seemed to be regarded as normal within the institution, and nothing was done about it.

While I was at Kerelaw, we were only allowed to see our families or leave the school on their terms. I found this very difficult and would sometimes sneak out during the week. When I did this, I would drink alcohol and take drugs.

Eventually, a panel considered my circumstances and decided that I should be placed in a secure unit. Following this decision, I was sent to Rossie Farm.
