My first memories of being in care were when I was sent to Latsold, Edinburgh Road Assessment Centre, where I stayed for around 10 months, which was far longer than originally planned. This was the first time I had ever been placed in care, and I was completely alone. From the beginning, I was picked on and bullied. Staff encouraged bigger boys to push me around and call me names, making me feel unwanted and isolated.

While at Latsold, I was punished daily, often by being slapped across the head. Staff also did this to other children. On many occasions, staff would take us into a room and allow older children to beat us up. This abuse was known and allowed to happen. I remember a staff member called John, who had a ginger beard. He appeared to know what was going on and tried to protect me, but there was nothing he could do to stop it. I lived in constant fear during my time there.

Your statement for Care setting 2 continued

I was then placed at Kibil Care Home, which was one of the most disturbing and confusing experiences of my life. There were many children with different issues, and the environment was constantly violent. Fights happened regularly, and staff allowed them to continue.

I was often locked in a dormitory with six other children, with no support or supervision. There were times when my feet were set on fire, and staff did nothing, even though they knew what was happening. They knew the right times and the right people to lock us in with so that abuse would occur.

I was forced to eat food I did not like, and if I refused, I was sent to bed hungry. I was beaten with canes and sandals. Older boys were allowed to punch me in the face while others laughed in the corridors. I was secluded and never allowed home on weekends. During my entire time at Kibil, I was never given a single home leave.

The abuse at Kibil happened daily. When I cried out for help, staff would beat me until I was black and blue. I never had visitors and was never allowed home, so I had no one to confide in and no one to protect me. Staff mocked and bullied me for having no family. I stayed at Kibil for around two years.

Your statement for Care setting 3 continued

I was then sent to St John's, where the abuse became even worse. This place felt like a jail, not a care home. Staff would come into our rooms at night, drag us out of bed, and physically beat us. At times, they would take our clothes away. Within my first week, I witnessed another child being beaten while naked. I was terrified for my life.

At St John's, staff regularly used canes and belts, especially on the tops of my knuckles, causing extreme pain. They laughed at me and deliberately tormented me. I was also subjected to sexual abuse. Staff touched me in sexual ways, touched my private parts, and forced me to touch their private parts. This has caused deep psychological harm and is something that has stayed with me for my entire life. I also witnessed staff sexually abusing other children. Everyone knew what was happening, but there was no protection and no hope for us.

During my time at St John's, I suffered a broken nose after being punched by staff. Instead of receiving proper medical care, I was taken to a nursery room, cleaned up, and left there alone for several days. I remained at St John's until I was 15 years old, when I finally escaped and went to live with my sister.

These experiences have had severe and lasting effects on my life. I suffer from depression, anxiety, and severe PTSD. I struggle to trust people, and the trauma I experienced in care has affected my relationships, mental health, and ability to live a normal life. The mental, physical, and sexual abuse I endured has caused long-term damage that continues to affect me every day.
