- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was in and out of here a few times in between different placements. My experiences there were horrible.

There was one occasion when I was attacked with a brick. Another boy and I had gone to collect the laundry when he suddenly threw a brick at me. Incidents like this made it feel like an unsafe and frightening place to be.

The staff were cold and unapproachable, and I never felt as though they genuinely cared about us. While I was there, I was also exposed to things that no child should have had to see or experience.

Some of the other boys could be extremely cruel and violent. If you asked for something, they might respond by saying things like, "Let me punch you in the jaw first." I also remember a boy from my area being stabbed in the back with a dart. He had gone over to the dartboard when another boy threw a dart directly into his back.

Looking back, what stands out to me is how little care or concern the staff seemed to show. It felt as though they saw so many children coming through the placement that they had become detached and stopped caring about the individuals they were supposed to be looking after.
