When I moved into Carluke Children's Home at 39 Station Road, Carluke ML8 5AD, the abuse started immediately. From the very first day, from the moment I woke up each morning, the staff would verbally abuse me. The verbal attacks set the tone for how I would be treated throughout my time there—with cruelty, contempt, and violence.

The staff would hit me regularly. There were times they would just kick me for absolutely no reason at all. I would be standing there, doing nothing wrong, and suddenly I'd be kicked. They would punch me as well. The physical violence was unpredictable and constant. I never knew when the next blow would come or what would trigger it.

Sometimes they wouldn't let me eat. They would withhold food as a form of punishment, leaving me hungry and weak. Being denied meals made everything worse—I was already scared and traumatized, and the hunger added to my distress and vulnerability.

I was terrified living there. The fear was so overwhelming that it caused me to wet the bed at night. I couldn't control it—it was my body's response to the constant trauma and stress I was experiencing. But instead of recognizing this as a sign that I was deeply distressed and needed help and compassion, the staff punished me for it. Wetting the bed would get me in trouble, and they would hit me again for something I couldn't help. It became a horrible cycle: I was scared, so I wet the bed, then I was beaten for wetting the bed, which made me more scared, which led to more bedwetting and more beatings.

The staff used various objects to hit me with. They would use rulers to strike me. They would use shoes as weapons. They used all kinds of things to inflict pain on me. It wasn't just their hands—they actively picked up objects to use as implements for beating a child.

I was only a child. Children are supposed to be protected, cared for, and treated with kindness, especially children who are already vulnerable and in care. Instead, I was treated with shocking cruelty. The staff at Carluke Children's Home shouldn't have treated me this way. Their behavior was inexcusable.

What made it even more traumatic was the randomness of it all. They would do things to me for no reason. There was no logic, no pattern I could predict or avoid. The violence and cruelty were arbitrary, which kept me in a constant state of fear and hypervigilance. I could never feel safe or relaxed because I never knew when the next attack would come or what might trigger it.

The treatment I received at Carluke Children's Home has left deep scars. The physical abuse, the verbal degradation, the deliberate cruelty, and the complete absence of care or compassion have affected me profoundly and continue to impact my life today.
