Your statement for additional care settings

I was placed here because I had run away from home. My memories of my time here are somewhat vague, but there are certain incidents that I still remember.

I remember there being drugs on the property that belonged to members of staff. I was also locked up on several occasions because I repeatedly ran away.

There was an incident involving another male resident whose name I still remember. He was violent towards me and sexually assaulted me. On multiple occasions, he touched me in places where I did not want to be touched and without my consent.

These experiences have remained in my memory despite other parts of my time there being difficult for me to recall clearly. Other than that incident, my time here was okay.
