- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was then placed at Brimmond. During my time there, I was locked up and isolated a lot. I was heavily restricted and had very little contact with other people. I felt as though I was pushed to the side and had no freedom.

I was prone to running away, and because of this, the response from staff was often to lock me up and isolate me. Rather than helping me, I felt that this made things much worse for me.

I also remember staff being verbally abusive towards me. I find it difficult to recall every detail of what happened during my time at Brimmond because I have tried to block a lot of those experiences out. However, I clearly remember the isolation, the restrictions placed on me, and the way I was treated by staff.
