Q1 | What is the name or location of the relevant care setting you were abused in?

- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

My time at Oak Bank was the worst of my care settings.

I suffered physical beatings from staff members. After I'd suffered a beating I'd run away. This mainly happened at night by the night staff and happened every couple of months.

At one point, I had 2 black eyes, the staff would blame it on me for struggling but no child should have to suffer living like that in a supposed trusted care facility.

The punishment I'd suffer when returning to Oak Bank was that I wasn't awarded any home leave which messed with my mental health.

The food here I describe as disproportioned. I'd see other kids getting more food than I did and to me, that wasn't fair at all.
