Your statement for additional care settings

I was then placed in Rossie Farm in which I was a young teenager. I started to self harm here in which was influenced by staff members wanting me to do it and hurt myself more. I was abused here by males and females in many ways. The male staff member would perve on me and try and take advantage of me by trying to sleep with me by touching me and wanting me to take my clothes off. They would touch my breasts and I'd tell them no and when I'd tell them "no" they were blackmailing me by telling me "if I didn't let them, they would restrain me" basically making me out like I'd then done something wrong. They would also try and put their hands down my trousers.

This was around 2-3 staff members who would constantly come to me when they were on shift to try and get advantage over me.

I was also attacked by other inmates here randomly, this would make me very scared and this is why I resorted to self harming as i was alone and had nobody to turn to.
