## Your statement for additional care settings

Glenochil was a detention center and the abuse still carried on here. This was from the other kids and guards.

I was in here for 6 weeks and 8 days.

I suffered beatings here by the officers, they would beat you for absolutely anything and knowing I was obeying with rules and still getting beatings would really mess with me mentally. The officers would come in to change my bed and whilst changing my bed they would beat me.

If my room wasn't immaculate to their standards I'd get a severe beating for it. Instead of being disciplined in the correct way, they would just beat me for it.

Overall, this has given me relationship issues with peers and partners. I unfortunately abusive to my ex partner with no intention of wanting to be. This was and still is built up emotions and pain from what I've gone through as a young boy.
