My first experience of being taken into care was when I was 12 years old. I was removed from my father's care in Kilmarnock due to physical abuse and taken to Kirkland's Park Assessment Centre, where I stayed for approximately three weeks.

From the moment I arrived, I felt frightened and completely alone. No one explained why I was there, what was going to happen to me, or how long I would be staying. I was not settled in or supported emotionally. Staff allowed me to smoke despite my young age, which shows how little care or protection was provided. Although I got on with some of the other children, many of them ran away regularly because of how badly the staff treated us.

I was spoken to aggressively and cruelly, and on several occasions I was slapped across the head by staff. This was the start of the abuse I would experience in care. Although it was distressing, I believed it would be temporary, as I was only there for a short time.

After around three weeks, I was returned to my father's care. The physical abuse became far worse. Over the next two years, I was regularly beaten and left black and blue. Despite this, I was failed again when social services later placed me back into care instead of ensuring my safety.

## Your statement for Care setting 2 continued

At the age of 14, I was placed in Kierlaw Children's Home in Stevenson. By this time, I was already traumatised. I felt scared, nervous, and extremely anxious, as I had already experienced how unsafe care environments could be.

From the start, Kierlaw was terrifying. The home was dominated by older boys, including skinheads, who ruled the unit through violence and intimidation. I was immediately targeted. I was pushed around, threatened, and verbally abused, being called names such as "bastard" and "unwanted." I remember being forced into fights because I had no choice. On one occasion, I was grabbed from behind and quickly realised it was a member of staff, not another child. This moment caused my fear to escalate badly. I was taken into a room and beaten with a rolled-up magazine, and on other occasions hit with belts, including the buckle, which caused bruising and injuries.

Staff labelled me as the "official gay boy" of the home. That is how I was known. I was constantly humiliated, isolated, and targeted. Staff would withdraw me from school whenever they wanted, and I was never allowed any privacy or time to myself. I was stopped from seeing my family and friends, and any spare time I had was deliberately taken away from me. Staff allowed other children to hit and bully me, and if I tried to defend myself, I was punished. I was taken into rooms by adults and beaten further. I was treated like a punch bag, and everyone knew not to speak out.

A staff member named John Muldoon attempted to sexually assault me on multiple occasions. I also witnessed him sexually assaulting my friends and other children. He lived next door to my mother and used this to threaten me and keep me quiet, making me terrified to tell anyone.

Another staff member, Mark George, was also sexually abusing children in the home. On one occasion, he tried to get me to stay with him at a "big house" for the weekend. When I arrived, other boys warned me about what was going to happen to me. I was terrified and escaped. The police later returned me to Kierlaw.

I lived in constant fear for my life, especially at night. I was often locked in rooms, sometimes with other boys who verbally abused me, calling me "gay boy," and threatening to beat me. I learned to stay silent and not react in order to survive. Staff deliberately pushed me around and kept me separated from other children who were also being abused.

I was beaten so often that my nose would regularly bleed. I was restrained in cold baths, held by my wrists until they felt broken. For days afterward, I could not properly use my hands or wrists. I was forced to shower under staff supervision while naked, and staff claimed they had to wash our backs, which was deeply humiliating and violating.

Food was used as punishment. We were given no choice, and if we did not comply, we were sent to bed hungry. Many nights I had to beg or behave submissively just to get food. This was extreme neglect.

Kierlaw was the worst place I ever experienced physical abuse. I was used as a punch bag, and everyone knew to stay silent.

At the age of 16, I escaped and returned to my father's care. Although I knew it was not safe, I felt less afraid there than I did in Kierlaw. A few months later, I was arrested by the police. I refused to return to Kierlaw. My mother asked to take me in instead of returning me to my father or care, as I was hiding at a friend's house and did not feel safe. My father refused and reported me missing.

I remember crying and screaming, begging not to be sent back to Kierlaw. The police told me I would go to prison. Instead, I was taken to a Children's Panel and placed back under Kierlaw's care, where I remained until I was 21 years old.
