St Johns - 18 months:

Punished by being made to stand completely naked all night because I ran away with three friends, two of whom were named Eddie Macalroy and Pat McCleary, with Eddie from Castlemilk and the other boy from Hamilton whom we called Sylvester. We weren't allowed to speak all night. We were struck with a large slipper on our bare backsides here. Baldy John was another staff member, and I was seized and pulled into the office where I was whipped with a solid leather belt. If you received this punishment, I would be given plastic shoes and small shorts to prevent me from escaping, and this would last for a week or until they decided it was enough as a warning against running away. Brother Robert would brush against you while doing joinery, but he never went beyond that with me. Every Sunday, we attended chapel, and I was made to be the altar boy.

Seniors and juniors, I was caught by the police while on the run, and they took me back. I ended up in a cell at St Andrews. A staff member named Dan walked around with a staffy dog, hit me a few times, and threw me into a cell until Monday morning, starting from Friday. There was a problem with the door, so I couldn't receive any meals. As punishment for running away, I was given shorts to wear.

Longriggend

From the very beginning, they didn't like me. They referred to me as an isol, which signified isolation. Longriggend was a different experience; I was just a teenager here. It was a terrible place, and it was clear that you would inevitably face serious trouble. Riots occurred frequently in this facility. You can't mistreat people constantly and not anticipate a reaction. I experienced a few altercations with the guards here. The culture in Longriggend was us against them. As a form of punishment, they would shave your head. All the prison officers from other facilities were transferred to Longriggend. I never had any privacy, even in the shower, as the staff had to supervise me because I was known as an escapee. At night, I had to use a 'night light,' which was harsh, so they could monitor me, making it difficult for me to sleep due to the brightness. Insults, swearing, and verbal abuse from the staff were commonplace. It felt like a warzone. I was physically assaulted at least six times here. Hearing others being abused was a regular occurrence.

Your statement for additional care settings

Borstal Detention Centre Glenochil

It was referred to as the shock sharp treatment – a place where everyone was messed around. Army style. The verbal abuse here was unparalleled. Left right, left right, with occasional slaps and kicks from the staff, but we just accepted it as normal, even though it shouldn't have been. We were given a pot to use overnight, and if we needed to go to the toilet, we had to use it. You definitely didn't want to use the pot because of the smell it created in your room overnight. We called them shite bombs, wrapped them in newspaper, and threw them out the window. The PO announced that someone had defecated in a jug and thrown it out the window, so he cleaned it and made tea in it, meaning you were drinking your tea from that. The next day, people had to pick it up and clean it up.

Reflecting on all this brings me down. After spending 30 years in the system, which as a child it began in care homes, it felt like being in prison, I believe it all traces back to my upbringing. I ended up using hard drugs, specifically heroin, in 1979, and now I'm on

methadone. I've struggled with mental health issues throughout my life, and my relationships have been significantly affected by the situations I've found myself in. My circle of friends who used drugs has diminished, as I've lost many to overdoses. I used drugs to escape reality, and heroin became a crutch, providing a false sense of happiness. Looking back now, I realize it was all an illusion. I wake up feeling depressed and socially awkward, and it all ties back to these experiences, interfering with everything in my life. I struggled with emotions because showing weakness was not an option in those places. These places were like universities of crime; the care system failed and backfired on its intended purpose. I

don't know how to express my emotions. I feel broken, and I'm doing my best to mend it all.
