When I think back to the different children's homes I was placed in, I realise how much of my childhood was shaped by fear, confusion, and a lack of genuine care. My time in Burnside Children's Home, which lasted around three to four months, was the beginning of a pattern I didn't yet understand. The staff there were often cruel towards me. They shouted at me when I didn't understand things and called me names that no child should ever hear. I was kept in my room for long periods, and while other children went out to do activities like swimming, I was left behind. There was also a man who worked there who was physically intimidating, and his presence alone made me feel unsafe.

After Burnside, I was moved to a home in Stevenson for about six months. The staff there were just as unkind, if not worse. They spoke to us in degrading ways and used the worst kinds of insults. When they restrained us, it wasn't done safely or calmly. Instead, they used excessive force, with several adults sitting on us at once, making it hard to breathe. It was frightening, and it made me feel powerless and unheard.

My next placement was a home in Newfield, where I stayed for another six months. The atmosphere there was harsh and hostile. The staff bullied us and used force unnecessarily. I ran away often because the environment felt unbearable. The staff would turn older kids against the younger ones, creating tension and conflict on purpose. They kept us separated and locked us in our rooms frequently, leaving us isolated and anxious. It felt like there was no one to turn to and no safe place to exist.

Eventually, I was placed in Snowdon on Spittal Street, where I stayed for over two years. I had hoped things might finally improve, but the same patterns continued. The staff would make up reasons to stop us from going out at weekends, taking away the little freedom we had. They locked us in our rooms for hours at a time and didn't feed us properly. Their words were often cruel, and the way they treated us made me feel small, unwanted, and constantly on edge.

Looking back on all these placements, what stands out the most is how little care or compassion I received. Each home was supposed to provide safety and support, yet I was met with hostility, neglect, and emotional harm. I was a child trying to survive environments that were never meant for healing or growth. These experiences shaped me deeply, and speaking about them now is a way of acknowledging what I went through and recognising the strength it took to endure it.
