- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I experienced significant emotional abuse during this period. I was taken from my grandmother's care and moved to Dundee, having been told that I would only be away for three weeks. In fact, I remained there for approximately six months and did not return to my grandmother.

During this time, I was prevented from seeing her. On one occasion, she came to visit me but was not allowed to see me and had to try to speak to me over a wall. I did not see her again until she was on her deathbed.

These experiences were deeply traumatic and affected me for many years. I required medication to help me cope with the lasting emotional impact.
