My first memories in life are not happy ones. They are of being taken away from my family and placed into foster care. I was very young, confused, and terrified. I was placed in a foster home in Money Heath, near Angus/Dundee, where I stayed for around one year. I remember the carers' names as Fred and Rose (I am not fully certain on Rose, but I am 100% sure about Fred). The abuse started immediately. I was screamed at constantly and often locked in my room. There was physical abuse as well — I was hit and handled aggressively. There were other foster children there, including a set of twins, as well as me and my brother. The carers would pick and choose which children they wanted to be kind to on any given day, and I was often the one ignored or targeted. I was never comforted. I felt completely alone, scared, and confused. I lost hope very early in life, and this lasted for the entire year I was there.

Your statement for Care setting 2 continued

I was placed with another foster family in Dundee, Rona and Davey McMaster, where I stayed for around four to five years. This is where the serious and life-changing abuse began. From the very beginning, I was slapped, pushed around, and subjected to constant mental abuse. They allowed their own children to bully me, hit me, and torment me daily. This is also where the sexual abuse began. One of their children, Dean McMaster, who was around 17 years old, repeatedly sexually abused me. He would come into my room, I would be left alone with him, or he would abuse me while I was in the bath. This went on for years. The foster parents were aware of what was happening and did nothing to stop it. They allowed it to continue.

Punishment in this house was violent — slaps, hits, and intimidation. You were not allowed to step out of line. I was constantly abused physically, mentally, and sexually in this placement. The children continually called me names and picked at me. I lived in fear every day. I stayed in this environment for five years, and it destroyed me.

where I stayed for around one year. During this time, I was still being sent on respite care back to the McMaster family, which caused extreme stress, fear, panic, and emotional distress. Being sent back to the place where I had been sexually abused was unbearable and deeply damaging.

By this point, my mental health was already severely affected by the sexual abuse. At Staffmore Cottages, the abuse continued. The environment was toxic and full of name-calling. Staff would restrain us violently, beat us, and hurt us badly. I was hospitalised due to the beatings. They could have killed us — we were beaten like animals. We were locked in our rooms, isolated, and treated with cruelty.

While I was there, I was also sexually assaulted by another resident, an older child named Claire Wiles. Staff were aware and did not care. I suffered in that place for around one year, completely unprotected.

I was placed for respite care with another foster family, Helen and Bob, for a few months. By this point, I was exhausted and hopeless from being passed around my entire life. They fostered older children who bullied me and attempted to have sex with me. Two of them were Alistair Rice and Jennifer Thompson. Jennifer was much older than me and groomed me. I did not understand what was happening — I believed this was what I had to do to keep people happy. I was bullied and pressured into it.

The carers were aware of what was happening and again did nothing. Everyone turned a blind eye. I was too scared to speak up because they were older than me. While I was there, they allowed me to smoke, and I became addicted. I changed as a person. I hated who I was becoming. They made me hate myself.

Your statement for additional care settings

I was placed in another children's home at Fairburn Street in Dundee for a few months. I was around 15, turning 16. I tried to escape this place repeatedly and would go to my dad's. The staff there also abused me — hitting me and mentally abusing me. They called me names and forced me to do things I didn't want to do. The abuse never ended.

There was a lot of sexual activity going on between children in that home, and due to everything I had already experienced, I was deeply traumatised by it. Eventually, I was released and left to go my own way, completely damaged and unsupported.

All of this has ruined my life. Over time, the constant abuse has destroyed my mental health. I struggle deeply with relationships and trust. I have never felt protected or given justice. I was degraded, violated, and dehumanised from a very young age. I suffer from PTSD, severe anxiety, nightmares, and ongoing mental health issues as a direct result of what was done to me in care. This abuse followed me through my entire childhood and has left scars that I carry every single day.
