Q4 | On the next page, please provide as much information as you can about:

- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I was placed here I was 13/14 years old.

I have a very strong memory of when we'd come back from homestay for the weekend, and the male staff members would always be at the front office and when we'd arrived we'd get searched by the male staff members and they would touch you inappropriately by searching the inside of my legs. They would also intentionally touch our breasts and around our bum. There wasn't any female staff members around to conduct this search. Us girls then just had to accept being groped by these men and this was so wrong.

This would happen every time we come back from visiting home or coming back to the facility itself.

In the end it become the norm for this to happen and there was no one around to report this too and to get back in you had to experience this.

It wasn't nice at all for a young girl to go through this.
