Your statement for additional care settings

When I was placed here I was around 12 years old. I was a young boy very scared of being away from my family.

On my first day I was attacked by another guy in the pool room with a pool cue. He had also threatened me and this left me on edge. I stood up for myself and didn't let myself get beat up but as a young boy this shouldn't be happening. We was split up and I was sent to my room.

This care setting was an open setting, you could leave the grounds easily. On 3 occasions I ran away as i didn't like nor enjoy being there and was home sick from being split up from my family. I was only placed here for committing petty crimes and when I've looked back as an adult on my time in care, I feel I shouldn't of been placed here.

The staff members kept me quite secluded from having a normal time in care, I even had contact with my family reduced and I don't understand why.

If i was naughty or acted a certain way I would be sent to my room without food. This only happened a few times but feeling that hunger going to bed wasn't a nice experience at all.

Overall being a young boy, I was glad to have been able to stand up for myself but that was because i had to. No staff members were there to protect me but i feel at a young age this shouldn't of been the case. It was still a scary experience for me being away from my friends and family.
