- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

I was taken to Weedings Hall because I was going off the rails at the time. My sister had been there before me, and my brother had been placed somewhere else. I think my mum put me there to scare me. I remember when I first went in, there was a man there and I was alone in a room with him. I remember him grabbing me in my private area and telling me that he would "see me later." I was very young and vulnerable, and I remember this happening clearly. Afterwards, a woman took me into another room to speak to me about things. She introduced me to another girl who was staying there. This girl was known for running away. I remember the windows being open and she suddenly jumped out and told me, "Let's go." I followed her, and we ran through a field and a tunnel. The staff told my mum that I had run away and the police were contacted. We were eventually found, but instead of taking me back to Weedings Hall, my mum took me home. My sister had also experienced abuse while she was at Weedings Hall, and my mum was aware of what had happened to her before placing me there. This is something that has always stayed with me. At the time, my mum was using drugs and struggling with her mental health. I believe she later ended up in hospital, and I was then taken into foster care.
