- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I was placed here, I felt like I was walking into a prison. I was interviewed and only 12 at the time. I was a tall boy and put with 14/15 year old boys but I was nowhere near mature at the time.

I unfortunately got into fights in order to be standing my ground and defending myself.

When getting split up after getting in to fights, the staff would restrain us in ways where they caused pain. My arms and legs would be locked and twisted up. When being twisted up I'd be leaned on with a knee. I can remember the aches and pains for days after. This was constant behavior from the staff and in all honesty, got worse the more fights I got in to.

I was really missing my family and being away from them made me really unsettled. This troubled me throughout my time in care and especially this care setting as the staff were rough with me, gave no care to us kids and felt like they got a joy out of causing us pain.

When describing this place like a prison, was because at night our doors would get locked which gave me senses of entrapment.
