- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

The Good Shepherd was run by nuns and was a very religious place. Religion was forced upon us. We had to attend a chapel outside the home, and we were made to go whether we wanted to or not.

The staff were not kind. They were very negative and seemed to enjoy showing their authority over us. They would slap us on the back of the head for no reason other than because they could. It made me feel frightened and powerless. I was placed there to be looked after and kept safe, but instead I was treated harshly and made to feel like I didn't matter.

This fits well as part of a witness statement and keeps the focus on both what happened and how it affected the client.
