Q1 | What is the name or location of the relevant care setting you were abused in?

- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

The abuse I then experienced from my mother was horrendous. It was absolute hell. My brother and I were starved, beaten and abandoned over and over again. I was still only a child myself, yet I was left to take on the role of a mother to my younger brother while my mother went through multiple relationships and failed to properly care for us. There were times when we had so little food that I had to steal food from the local allotments just so that my brother could eat. I should never have been put in a position where I was responsible for making sure another child was fed and safe. I was a child too, and I needed someone to protect and care for me. What makes this particularly difficult for me is knowing that we had already been known to Social Services and had previously been taken into care after our mother abandoned us. When she took us from the home, I feel that nobody made sure we were safe or properly followed up on what had happened. We were left in an unsafe situation where the abuse and neglect continued. During this time, my self-harming became significantly worse. I was struggling so much with everything that was happening to me that I harmed myself repeatedly. Even now, almost every area of skin that I can see is covered in scars, which are a lasting reminder of what I was going through. I felt completely hopeless and abandoned. I remember praying that either I would die or that somebody would finally find us and realise what was happening. I desperately wanted someone to come and help us, but nobody ever did. I was still a child and should never have reached a point where death felt like the only alternative to someone coming to rescue us. I needed protection, care and support, but instead I felt completely forgotten. I strongly feel that if we had been properly looked after, protected and cared for, we would never have been left in that situation. We needed adults to safeguard us, but instead I was left trying to protect and provide for my little brother while having nobody there to protect me.
