Q1 | What is the name or location of the relevant care setting you were abused in?

(For example, the name of the care home, or the city or region where you lived in foster care or while boarded out).

Q4 | On the next page, please provide as much information as you can about:

- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

You can continue on additional pages if you need to.

Your statement for additional care settings

I remember being shouted at frequently and being physically hurt. I was sometimes grabbed by my hair and had my scalp pulled. We were not properly looked after, and there was very little care or support. I often felt neglected.

One incident I remember is when I was having one of my meltdowns. I think she couldn't cope with the situation and threw a box down the stairs at me. The box hit me on the head while I was on the stairwell.

Nothing was really done about what happened. As far as I remember, there wasn't any investigation or action taken. I was simply moved to different carers.
