## Your statement for additional care settings

When I was fostered by Wilma & Ronnie Christie I was also with my brother. They used to hit us hard and I was only little. I would also miss out on meals due to how horrible they were to us. We were always covered in marks from the physical abuse and our social worker was aware of this and visibly seen this. We were also always dirty and with us being so hungry we would also look through bins for food. We would also try and look in the cupboards for food because we were so hungry and we got caught and hit for it which again wasn't nice to go through at a young age.

My mum would have supervised visits with my social worker and I told my mum that my foster parents were hitting me and we were hungry and I remember crying telling her that I don't want to go back to them as Ronnie was a big man and when he hit us he hit us hard. Being a young hungry child I felt so scared and vulnerable.

Wilma & Ronnie Christie did make efforts to bath us but they were rough in terms of my head hitting the tap, throwing us in the bath instead of being carefully placed, we were left unattended and there was other kids in the house too and they would hold the handle up to lock us in so we couldn't get out and I remember screaming for us to get out.

The other kids would also come in to my room at night and hold our noses to make us choke when breathing.

I believe that Wilma & Ronnie Christie lost their right to foster not long after we left due to negligence.
