- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I turned 16, I had to leave the children's home because I was considered too old to stay there. Social Services placed me in a flat on my own and simply left me to cope. I was still only a child myself and was nowhere near ready to live independently. When I turned 16, I was assigned a social worker called Vince Green. He did nothing to support or help me. Instead of preparing me for independent living or making sure I was coping, I felt completely abandoned. My mental health deteriorated rapidly. I fell into a deep depression and eventually attempted to take my own life. Even though I was still under the care of Social Services, they did absolutely nothing to protect me or provide me with the support I desperately needed. I felt they had failed me throughout my time in care, and they continued to fail me after I left. I was left alone in that flat for about a month. I was not well enough to be living by myself, but nobody seemed to care. After my suicide attempt, I was taken to hospital. When I was discharged, I was sent to Eyemouth, where I stayed with a supported landlady called Edith for around nine months. After that placement ended, I was moved into a homeless shelter until another flat became available.

Looking back, I believe Social Services set me up to fail. Rather than helping me build a future, they abandoned me at one of the most vulnerable points in my life. Being left to cope alone at just 16 destroyed my confidence, severely damaged my mental health, and left me feeling completely worthless. I believe this failure to support me had lifelong consequences. It robbed me of the chance of a stable future and contributed to me becoming trapped in an abusive relationship when I was just 18 years old. The way I was treated has had a lasting impact on my life and my mental health, and I continue to live with those consequences today.
