Q1 | What is the name or location of the relevant care setting you were abused in?

- the abuse you experienced while living in this care setting
- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

At this care setting, if you were considered to have misbehaved, members of staff would restrain you. At times, you were effectively confined to your room, with staff standing outside the door. There were also occasions when it felt as though staff did not really care what you were doing, as long as they felt they had control over you.

Punishment was a constant part of life there. Your pocket money could be taken away and other privileges removed. If you then ran away because of how you were feeling or how you were being treated, you would be punished again when you returned. It became a cycle of punishment that often made things worse rather than helping.

While I was there, I had a sexual relationship with another person in the setting. Staff were aware of this, but as far as I remember, they did not take any action or intervene.

There was also an incident where a member of staff assaulted me. I remember going down some stairs afterwards and contacting my sister. I cannot clearly remember whether the police were called, but I do remember speaking to my sister about what had happened.

I am not saying that I was a perfect child. I had been placed there because of my behaviour and because of difficulties relating to my mother's mental health. However, I do not believe the way I was treated always helped me. When staff made no real effort to understand or support me, it often made me feel even angrier and more frustrated. Instead of helping me deal with my behaviour and emotions, some of the treatment made those feelings worse.
