- what life was like for you during this time
- how the people responsible for your care and welfare failed to carry out that duty (within or beyond your care setting)

Your statement for additional care settings

When I was placed here I was 11 years old. At first this setting was ok, I kept myself to myself and then I started to make friends to make my time better here.

I gathered a friend group here and then there were times the staff members would see me as a target for some reason.

I was physically abused by these staff members. I was out of place, I didn't like being in care and I certainly didn't like the way these staff members treated me and others, therefore I did answer back and was a little unsettled but this would be due to being a young boy away from my family.

I remember a staff member grabbing me and lift me up, took me to my room and threw me in my room and I wacked my head on the radiator. Fortunately this didn't cause me to bleed. I then remember shouting "you've just hit my head off the radiator" in which i was told to "shut the **** up".

I just didn't like how we was treated or handled here, I used to run away from here a lot and every time I was brought back I would then be manhandled and thrown in to my room.

My window was also locked shut moving forward so I was then not able to even open my window.

To this day this gives me nightmares still and my son has come in and asked me if I was ok due to me shouting in my sleep "leave me alone". This has left me restless and unsettled. I'm unable to sleep well since I left the care system.
