When I was around thirteen, I was placed in a mental health facility due to the struggles I faced with my own mental health. My mother also suffered from poor mental health and found it difficult to manage her own, leaving her unable to support me through mine. This decision was made through a children's panel, and I was placed in multiple Quarriers homes in and around the Dumfries and Galloway area, including one in Thornhill, one in Dumfries, and another in a small village on the outskirts. I remained in care until I was sixteen, when I was supported by ThroughCare in getting my first home. During my time in care, I was pushed and shoved by staff, and male staff members would hold doors closed, locking me in rooms with them, which was incredibly intimidating. I regularly witnessed other children being physically hit, and this happened often. Some staff members even provided me with drugs such as cannabis and ecstasy, exposing me at a very young age to substances that blurred boundaries and created an unhealthy relationship with drugs. This escalated into a heroin addiction that I suffered from throughout most of my life until two years ago. As a child, I did not recognise the harm it was causing or the dark and painful period it would begin. I wet the bed while in care and was humiliated and shamed for it, something I am still working through in therapy. Punishments included being locked in small enclosed rooms for up to five hours at a time, which felt like an eternity, and when I ran away, my access to the fridge would be removed. Bullying among residents was relentless, and although staff were aware, they did nothing, leaving us to deal with it ourselves. Showers offered no privacy, as staff would watch me, claiming it was because of my self-harming. There were three staff members who behaved in sexually inappropriate ways, one watching me as I dressed and undressed, and two others making comments about my developing body. Visits with my family were denied, and I was not allowed any contact with my brother, meaning we missed out on crucial years of our childhood together that we can never get back. After leaving care, ThroughCare helped me secure my first home, but at such a young age, and having already been exposed to unhealthy boundaries, it felt like a recipe for disaster. I was completely unprepared for independent living and in many ways set up to fail. These experiences have had a profound impact on my mental health, and I have had to engage with multiple services throughout my life for support. I continue to struggle with relationships and friendships due to deep trust issues, and I still suffer from flashbacks and nightmares. I am currently undergoing EMDR therapy to help process the trauma I experienced.


