

I note that you wish to apply to vote by post. The process for applying for a postal vote in Scotland depends on the type of election.

For **Scottish Parliament and council elections**: you will need to complete and return **Part A** of the enclosed form.

If you are unable to apply online for a **UK Parliament** postal vote, you can use the enclosed form **Parts A and B** to apply to vote by post at **UK Parliament, Scottish Parliament and council elections**.


