I was taken into care after getting into a lot of trouble at home. My stepfather physically assaulted me very badly, and as a result, he was taken to court. Social Services had already been involved with my family for some time before this incident. Following the assault, it was decided that I could no longer remain at home, and I was taken into care.

My first placement was at Colonsay Children's Home. After some time there, I was placed with a foster family. I found it very difficult to settle and eventually ran away. The police found me and took me back, but I refused to return to the foster family. Because of this, I was taken back to Colonsay Children's Home.

I was then brought before a Children's Panel, who decided that I should be placed at Burnside Assessment Centre for further assessment.

I was only 10 years old when I was placed there. We were locked in seven days a week, and I felt like I had no childhood at all. The only time we saw daylight was when we were taken to Asda once a week. I lost out on my education because, although we were told we would receive schooling while we were there, we were never taken to school or given a proper education.

The home was split into different units for different age groups. We were taken for meals three times a day, but the food was very basic, and it was a case of eating what was put in front of you or going without.

One staff member would force me to eat food that I could not manage. I was made to keep eating until I vomited all over the table. Instead of being comforted or helped, I was made to clean up my own vomit and then placed in solitary confinement for two days. During that time, I did not see or speak to anyone. This happened regularly because I was a fussy eater. I was forced to eat foods I could not stomach, would vomit in front of everyone, and then be punished for it. This happened around once every two weeks.

It was incredibly humiliating. All of the other children would watch me being sick, and I felt embarrassed, ashamed, and completely vulnerable. I also witnessed the same treatment being inflicted on other children.

The whole place felt like a prison. We were not allowed visitors, and we were not taken home to see our families. It was not a proper school, and instead of having a normal childhood, I spent my time feeling locked away and isolated. The experiences I had there have stayed with me throughout my life, and I still suffer from nightmares about what happened.

The home was run by NCH (National Children's Homes), and the manager was a man called Bill Allison. The school had large grounds, and although there were some positive aspects, the way children were disciplined was frightening and abusive.

If you got into trouble, Bill would take you over to what we called the chapel, where he made us do judo. Instead of using it as a sport or activity, he used it as a punishment. He would make children fight each other, and if you had done something wrong, he would use you to demonstrate the judo moves, leaving you to be thrown around in front of everyone else. Bill also physically assaulted me. He would repeatedly jab and punch me in the chest with his fingers, deliberately choosing places where the bruises would be hidden beneath my clothing. I believe he knew exactly what he was doing so that no one else would see the injuries. There was a staff member that lived with her husband on the grounds. On one occasion, I remember he grabbed me by the neck, dragged me headfirst into the laundry room, and made me sleep there overnight. The window did not close properly, and I was left alone in the cold, freezing throughout the night. His wife was also physically abusive. She had very long fingernails and would grab me by my arms, dragging me along the corridors. As she dug her nails into my skin, she would leave cuts and scratches on my arms. I remember it being painful and humiliating. On another occasion, two other boys and I had been having a water fight. As punishment, Bill took us out of the home in the middle of the night wearing only our nightwear. He made us walk for around three miles through fields, forests, the palace grounds, and through the town before returning to the home. I remember it being around midnight, and it was frightening to be made to do this as a child. During my time at the home, I was sent home at weekends as part of what they described as reintegrating me with my family. A man I was told to call "Uncle Robert" would collect me every Sunday and take me back to the home. He would buy me cigarettes and sweets, and then sexually abuse me by making me touch his genitals. I realise that the treats were all bribes, most likely to keep me quiet. I tried to tell people what was happening. I spoke to staff at the home, including Bill Allison, as well as my social worker and my parents. Instead of protecting me, I was called a liar and accused of trying to cause trouble. No one believed me or investigated what I had said. I felt completely abandoned. The abuse continued because the adults who should have protected me ignored what I was telling them. I became so desperate to stop having to go with this man that I deliberately got myself into trouble at school so that I would be suspended and lose the "privilege" of going home at weekends. Eventually, I was expelled. Looking back, I feel that getting expelled was the only way I could make the abuse stop.

Foster placement with relatives

After I was expelled, the home simply sent me to live with my sister and brother-in-law. No one checked whether it was a suitable place for me to live. There were no carpets, I did not have a bed, and I had nowhere to keep my belongings. My sister and brother-in-law received foster care payments for looking after me, but they spent the money on themselves instead of providing for my needs.

I often went hungry. My best friend's mother was the person who fed me because there was little or no food provided for me at home. I remember my sister sitting in front of me eating while I was left to starve. It felt as though everyone had washed their hands of me, and once again I was left without the care, protection, or support that I desperately needed.

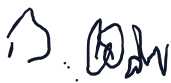
