observed and recorded in the notes that Leon spends very little time on his feet and is almost always propping himself when standing. When successful in getting Leon out of the home, he has not managed more than 5 minutes outside before going back in and sitting down. In addition to Leon physically struggling to stand for any length of time, it is important to note that despite daily support and prompting, Leon is not engaging in the work required to move towards his goal.

It is unclear to OTAP whether Leon's fear of collapsing and thus panic about leaving the home is the reason that he does not want to stand for any length of time. Or, if it is the lack of standing and movement (fitness and stamina) combined with foot pain, that is exacerbating the fear of collapse and anxiety. Leon has previously had input from Steven Adamiak, Exercise instructor within the Mental Health Physiotherapy department at Stratheden Hospital. Leon was eventually discharged from this service due to lack of engagement.

OTAP has discharged Leon today with the advice to maintain his foot health through proper medication use and self-care, and to work on his endurance to stand by engaging with his support staff and befriender in activities which involve standing and moving. Such as playing pool often, trying to avoid leaning on the table and sitting in-between turns, and engaging in short walks. OTAP used these examples as this is what Leon himself has consistently said he wants to start doing. OTAP

raw with Leon stating that they are
sore. It would be reasonable to
assume that the condition of
Leon's feet is contributing to his
issues with standing for any length
of time.

OTAP recommended Leon get in
touch with his GP to have them
looked at.

silent on the topic.

OTAP explained the purpose of the
OT sessions to Irene. Irene
explained that she has had Leon
out in the car before and that some
of the staff are happy to use their
cars for supporting and others are
not. Irene said she was happy to
start supporting Leon towards his
OT goals of getting out more
independently. OTAP provided
Leon and Irene with a copy of
Right Now 54321 and encouraged
Leon to practice this in his home
when he is calm; Irene confirmed
that she would share this
technique with the other staff and
that they would be happy to
facilitate practice. OTAP suggested
reinstating the supported walks
Leon used to go on as a good
place to put these techniques into
practice. Leon said he would be
happy to go out for short walks as
long as the weather is nice. Irene
also suggested using a song to
sing as a distraction which OTAP
would be happy to facilitate to see
if this would work for Leon.

Leon was dressed and ready for his graded exposure session with Occupational Therapy Assistant Practitioner Suzanne Webster (OTAP).

Leon did try to avoid being out by the bus stop, preferring to just go to the shop. OTAP negotiated with Leon to accomplish both. When out, Leon does behave in the manner of someone who is very uncomfortable in his environment; walking fast, and moving in a hurried, unnatural way when in the shop, collecting and buying items. Leon attempted again to go straight home after buying crisps and bread. OTAP encouraged Leon to stay out, a little bit down from the bus stop as there was a man waiting there. OTAP worked through Right Now 54321 with Leon which he managed to focus on. However, as soon as this was completed, Leon walked back home.

Leon did manage to stay out of his house for 5 minutes.

Back home Leon explained that his head was filled with panic but he did say that Right Now 54321 helped him a little bit.

Next appointment arranged for Friday, 09/02/2024 at 11am which is the same time as Leon's Richmond Support. The goal will be to stay out for longer than 5 minutes and for Leon to try and give more details during the grounding technique.

Leon has telephoned CMHN on 3 separate occasions this week and I was able to return his calls this morning.

We spoke on the phone for 10 minutes.

Leon shared his frustrations that Senior support worker Graham Lumsden is "dragging his heels" about a request Leon has made for money recently and this is stressing him out. I enquired if he was referring to the request of £2,750 for a new guitar that we spoke about at our last appointment and Leon said it was. Through discussion Leon acknowledged that this is a particularly large amount of money and that this is why it was taking a while for Graham to process this request. Leon does recognise that he has a tendency to over spend his money which is why Richmond support him with budgeting.

Leon also shared that his son had contacted him to inform him that Darren's mum (Leon's ex) has undergone surgery to have part of her lung removed. This has impacted on Leon in that he has been worrying about his son going through a difficult time with his mum. CMHN validated his concerns and offered support and reassurance.

He shared that he is feeling overly tired, sleeping well overnight but also napping alot during the day too, also he is experiencing a flare up with his eczema.

On a more positive note Leon's next book is due to be published on his birthday 17/3/26. And he spoke about hoping to go for a meal at the newly opened pub around the corner from him.

Leon enquired as to what was happening with his referral to the community rehab team. I advised

Mr Gratton had blood tests rechecked at the Weston day hospital on 04/03/25 and these have shown abnormalities in his FBC as follows - I wrote to his gp to inform them of this on 7/3/25:

WBC 20.3 (normal = 4.0 - 10.0 x 10⁹/L)

Neut 17.15 (normal = 2.00 - 7.00 x 10⁹/L)

Physical observations were:

Blood pressure = 140/75, pulse = 116 bpm (sinus tachycardia longstanding with Clozapine) and his temp = 36.8, O2 sats = 95% on air and no complaints reported other than skin inflamed.

A week ago when attending his CPA meeting I noted his skin was very inflamed and I wonder if this is contributing to his high infection markers.

Given that he is taking Methotrexate and FBC abnormalities have worsened, please could the practice consider reviewing his recent blood results and consider whether any further intervention is required at present.
