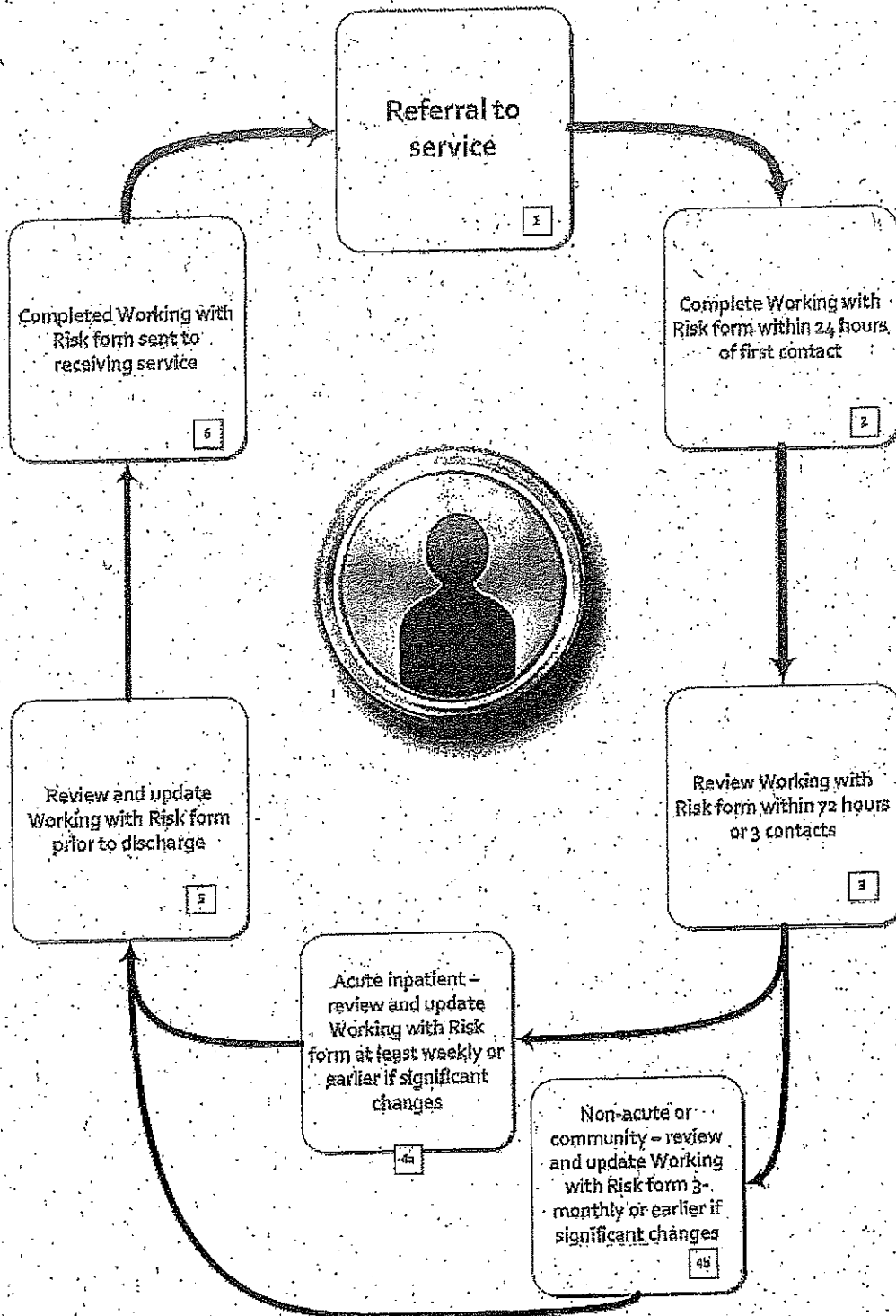

Description of Need:

Patients treated with clozapine, require close monitoring due to the risk of adverse effects particularly during the early stages of treatment.
Haematological monitoring is mandatory as set out by the Zaponex Treatment Access System (ZTAS). Additional clinical monitoring is required to identify other serious side effects and less serious side effects which can be minimised by dose reduction, reducing the rate of dose increase, adjusting the timing of the doses, or by prescription of additional medication to treat the side effect.

Objective/Expected Outcome:

To optimise the benefits and minimise the risks of treatment with clozapine by monitoring for and reporting side effects.

Cpn took mr gratton to his gp on 29 july as psoriasis continues to be causing problems , gp prescribed antibiotics but also chased up a dermatology referral. Cpn took leon to vhc later that day for treatment to be started. cpn visited following week twice daily to apply treatments as Leon due to negative symptoms appears not to be applying creams correctly or as often as he should be returning to dermatology On 1st 5th 8th 12th 15th and the 19th of august , unfortunately his skin condition is not responding as it should be mainly due to leon not being able to comply with the treatment plan , his Richmond support workers are not allowed to put creams on him and there dosnt appear to be service that would do this . the staff at the victoria would like to have leon attend daily inorder to ensure he is receiving the correct treatment bandaging his arms and torso and legs . Unfortunately leons mental state does not allow him to use public transport to attend their on a daily basis . Staff at dermatology have referred leon urgently to be seen by a visiting dermatology consultant (from ninewells) at the adamson hospital to try to facilitate a more robust treatment plan which can be carried out in the local area or at the adamson hospital . Again the problem will be getting him there as his mental health problem of paranoia restrict him from venturing out of the house. Unfortunately his cpn is on holiday for next three weeks .
