**LEON GRATTON, 85 SPITTALFIELD ROAD, INVERKEITHING KY11 1DZ
(DOB: 17 03 1975)**

The above named person was assessed by the Mental Health Assessment Team on 22nd November 2010. The patient was seen in Ward 8 at Queen Margaret Hospital.

Patient's Profile

A 35 year old man well known to psychiatric services. Has support from the Community Outreach Team and Richmond.

Presenting Complaint

Took a mixed overdose of Citalopram, Procyclidine and street bought Diazepam. The reason he gave for taking the overdose was he was feeling down and felt as if everyone hated him. He also said he thought about the baby he had to his ex-partner every day which was given up for adoption. Leon said that a Social Worker had told him to start a trinket box for the baby but he said he didn't want any further contact with his ex-partner and that the last he had spoke to her was 2 weeks ago. He stated he had tried to contact the Samaritans prior to taking the overdose but was unable to contact them. He contacted emergency services himself. When I asked if anything else had contributed to the overdose he said that otherwise things were "pretty much the same".

General Psychiatric and Medical History

Schizophrenia, borderline personality disorder and depression.

Current / Recent Medication

Flupenthixol IM weekly at Carnegie Clinic, Diazepam prn and Nitrazepam, Trihexyphenidyl.

Full Family History

Already well documented.

Full Personal History

Already well documented.

Social Circumstances

Lives on his own. Enjoys cooking, baking, writing poetry and kickboxing. Stated his relationship with his ex-partner was problematic and that he didn't want any further contact with her. Stated she treated him "like shit". Has weekly support from the Community Outreach Team. Support from Richmond 3 times a week. However he stated they may cut back his hours as at times he has not answered the door to them.

Alcohol and Drug History

Denied alcohol use. Admitted to buying Diazepam off the street. He did say that he felt this was becoming a problem as he was spending all his money on this and that he had contacted West Fife Drug Team for help. Denied any other drug use.

Forensic History

Previously documented.

Mental State Examination

- **Appearance and Behaviour**
Casually dressed. Made reasonable eye contact.
- **Mood**
Subjectively felt he was depressed and put his mood at 1/10. Objectively mood appeared low.
- **Appetite**
He felt he wasn't eating as much as he used to but hadn't noticed any weight loss. Said he tends to snack a lot.
- **Concentration**
Longstanding poor concentration levels.
- **Sleep**
Stated he buys Diazepam to help him sleep. Feels he only gets 2 hours sleep with Nitrazepam.
- **Speech**
Normal.
- **Thoughts**
He felt there was an "arrogance about people" and that the only person who was decent to him was Muriel.
- **Perceptions**
He felt his voices were worse and were reading out death threats to him. He also felt people were whispering in his ears.
- **Cognition**
Orientated to day, place and time.
- **Insight and Risk**
Insight was reasonably good. He has taken previous overdoses and admitted he had a problem with an addiction to Diazepam.

Assessment of On-Going Suicidal Ideation or Intent

Denied any on-going thoughts of self-harm. Stated he took the overdose due to feeling depressed and feels he has a "miserable existence".

Potential for Positive Risk Taking

Has a 12 year old son who he sees monthly. Was unable to contact the Samaritans prior to this overdose but uses their support and finds it helpful. Leon has support from the Community Outreach Team and Richmond. Leon stated he was at his happiest while working with Craig, Support Worker with the Community Outreach Team, at the gym and would like to go back to this but realises this would be dependent on staff availability and resources.

Clinical Impression / Formulation

A 35 year old single man who is well known to psychiatric services and has regular weekly support in the community from Richmond and the Community Outreach Team. He took a mixed overdose of Citalopram, Procyclidine and Diazepam due to feeling depressed and thinking that everyone hated. He had also been thinking about his child that had been given up for adoption. Leon admitted to an addiction to Diazepam which he buys off the street but stated he had contacted and left a message with the West Fife Drug Team to gain support with this. He denied any on-going thoughts of self-harm and he will be followed-up with his community support.

Prior to assessing Leon I contacted Dawn, his keyworker from the Community Outreach Team. Dawn stated she had seen Leon yesterday and at that time had no concerns about his mental health. She said he had missed his last 2 appointments with Dr Cavanagh and that Leon was responsible for arranging a further appointment himself.

Management Plan

Due to attend Carnegie Clinic for depot injection tomorrow. On-going support weekly from Dawn at the Community Outreach Team. On-going support from Richmond. Leon to contact Dr Cavanagh to arrange an out-patient appointment.

The patient was seen in A&E at QMH.

Patients' profile:

Leon is a 35 year old who arrived at A&E following an overdose of 12 x 10 mg Diazepam (street drugs). He is well known to the psychiatric services and Dr Cavanagh. He has a schizophrenic illness, borderline personality disorder and depression.

Presenting Complaint:

Leon was referred for assessment by A&E as, due to low mood, had taken an overdose of 12 x 10 mg of Diazepam. Expressed at this time he just wanted to "sleep away his problems", "make them go away". Attributes his low mood down to him splitting up with his partner in August 2010, as she had placed their baby up for adoption. He stated that he had none of his prescribed medication, therefore decided to go and buy "drugs off the streets" to help him calm down.

General Psychiatric and Medical History:

Schizophrenic illness. Borderline personality disorder. Depression. Well known to Dr Cavanagh and many admissions to Ward 2.



Current / recent medication:

Well documented.

Allergies:

None known.

Previously well documented. Not getting on well with his mother at present, does not feel supported by her "I'm not good enough in her eyes".

Previous history of minor physical assaults towards family members. No offences outstanding.

- **Speech:** Normal in rate, rhythm and tone (although at times quite quietly spoken. Answered questions appropriately.
- **Thoughts:** Feels that people are laughing and talking about him at times. More paranoid of late.
- **Perceptions:** Denied any at present, but did say he "experiences strange smells at times".
- **Cognition:** Orientated to time, place and person.
- **Insight:** Good insight, realises the consequences of outcome of further overdoses as he stated he has already damaged his liver.

Leon attended the Carnegie Clinic on 3 June 2010 for his anti-psychotic depot medication. He complained to the nurse about feeling very stressed, somatic symptoms such as pain in chest and back passage, hearing screams and hearing neighbours making strange noises. He also said he sensed people in his room at night.

I have therefore provided him with a script for 2 weeks supply of Chlorpromazine 25mg p.r.n. up to twice a day, daily dispensing.

He will be seen regularly by the staff from the Community Outreach Team and I will review him in due course.

Re: Leon Gratton, 85 Spittalfield Road, Inverkeithing, KY11 1DZ (DOB: 17.3.75)

I reviewed Leon at the Continuing Care Clinic on 12 November 2009 at Carnegie Clinic.

It was my first meeting with Leon. He had attended the depot clinic and had requested to be prescribed something to help his shakes and the left arm. I did a full examination to check for Extra-pyramidal side effects. There was presence of fine tremor on both hands, but more so on the left. There were some involuntary movements of his toes. There was no evidence of akathisia, dystonia or tardive dyskinesia. His gait was normal.

In the past, he had been prescribed 2 different anti-cholinergics, but they gave him side effects. Procyclidine had no beneficial effect and caused hallucinations. Orphenadrine helped his symptoms but gave him nightmares. Dr Cavanagh, Consultant Psychiatrist, had mentioned at a team meeting that he had planned to offer Leon a trial of Trihexyphenidyl (or Benzhexol). **I have therefore given him Trihexyphenidyl Hydrochloride 1mg o.d. for one week, to be increased to 2mg o.d. for one week. Either Dr Cavanagh or I will review the medication after 2 weeks.**

As far as his mental state is concerned, it has remained largely stable. He experiences second person auditory hallucinations a few times a week, which can be both inside his head or coming from outside. He finds them distressing but copes with them. There was no evidence of thought interference or thought alienation. He also spoke about experiencing "bad dreams" but would not elucidate further on it. He described his mood as "alright" and denied any hopelessness. He said he drinks "too much" alcohol.

He continues to receive input from the Community Outreach Team and outpatient appointments with Dr Cavanagh.

Current medication: **Trihexyphenidyl Hydrochloride 1mg o.d. for 1 week, 2mg o.d. for 1 week**
Inj Flupentixol Decanoate 150mg i.m. weekly
Citalopram 20mg mane
Nitrazepam 10mg nocte

Patients' profile

Leon is a 34 year old man who arrived at A&E by ambulance after texting his girlfriend to say that he had taken an overdose. He presented as unkempt and tremulous due to the high caffeine content of the tablets he consumed. He is well known to Dr Cavanagh and Ward 2. Leon has a schizophrenic illness, depression and a borderline personality disorder.

Presenting Complaint

Leon was referred for assessment by A&E due to him voicing suicidal ideations. He has a long history of disturbing hallucinations and tonight they appeared to be more distressed. He had no PRN medication which he uses and finds helpful at these times and had no credit on his phone to call Ward 2 for support.

Brief history of DSH event

Mixed overdose at 0200 hours in response to distress caused by auditory, visual and tactile hallucinations. He wanted to "pop his heart and kill himself".

General Psychiatric and Medical History.

- Borderline Personality Disorder.
- Schizophrenia.
- Depression.

Current / recent medication

- Flupenthixol 150mg IM weekly.
- Chlorpromazine PRN.
- Diazepam PRN.
- Nitrazepam at night.
- Has not been taking his full prescription of prescribed medication because his girlfriend has been using them.

Full family history

- Previously well documented.
- Not speaking to his mum – she is “a bitch” and wants Leon dressed her way “tinky”.

Full personal history

Previously well documented.

Level headed, sensible and astute.

Social circumstances

- Lives on his own in a Council flat – happy with his home.
- Has been with his girlfriend Vivienne Black for 6-7 months mainly gets on well with her however she can be physically aggressive towards Leon and uses Diazepam and Chlorpromazine medication.
- Support from West Fife Community Outreach team, Richmond Fellowship x 3 times a week (Monday, Wednesday and Friday).
- CPN Dawn Stanley.
- Has a few good friends.

Alcohol and Drug history

- Smokes cigarettes x 20 a day.
- No illicit drugs – hates drugs but his friends and girlfriend use them.
- Rarely drinks alcohol but had a bottle of Becks tonight.

Forensic history

Punched mum.

Punched George – mother's husband.

Threatened to blow up Social Work Office.

} All admonished at Court.

Mental state examination

- **Appearance and behaviour**
Unkempt, hair uncombed, casually dressed.

- Son, Darren 11 years old.
- Vivienne Black, girlfriend.

Clinical Impression / Formulation

This 34 year old man is well known to the Psychiatric Services and has lots of support in the Community. Last night he took an impulsive overdose of mixed energy pills due to distressing hallucinations. He usually seeks support from Ward 2 or uses his PRN Medication however his girlfriend had used his medicine and he had no credit for his mobile phone. Leon has a long psychiatric history and has had several overdoses in the past without requiring medical intervention. He acknowledged that he could have caused himself harm but at the time he believed it was the only thing he could do, query if this is due to his depot being due today. No longer voicing suicidal ideation and is positive about his plans for the rest of the week.

Management plan

- Discharge home.
- Appointment with Dr Cavanagh on **Wednesday 21 October 2009 at 3.00 p.m.**
- West Fife Community Outreach Team to be informed and request contact more often.
- CPN to see Leon today if possible.
- Depot at 10 a.m. today at Carnegie Clinic.
- Requested that Leon either stays with a friend this morning or a friend calls in to see him. However he said that his friend was busy with her son and that Leon himself would keep himself safe.

I reviewed Leon in the out patient clinic on 21st October 2009. I had heard from my colleagues at the Outreach Team that his mental state was raising some concern of late. Leon himself admitted to hearing voices two or three times a week which are often in the internal and external space and which he has found distressing. He also described persistent and pervasive low mood, anergia and anhedonia. This is the first time that I have seen him for a while, as he has missed a number of appointments this year. His engagement with the Outreach Team however has been reasonable.

He receives his depot antipsychotic medication weekly and his present dose of Flupenthixol is 150 mgs weekly. He is also on Nitrazepam 10 mgs nocte which he receives on a daily prescription from the pharmacy. We discussed a trial of Citalopram 20 mgs daily which he would like on daily dispensing also.

Patients' profile

Leon Gratton is a 34 year old unemployed gentleman who lives alone. He is well known to the Psychiatric Services. He has a diagnosis of schizophrenia and borderline personality disorder.

Presenting Complaint

Leon was referred to the Mental Health Assessment Team by staff in A&E for assessment following an impulsive overdose of 4 Paracetamol tablets and 4 Simvastatin tablets. Leon described waking up around 2 o'clock in the afternoon and could hear screaming outside the building stating he "suddenly got depressed and wanted to die".

Brief history of DSH event

Leon woke at approximately 2 p.m. and stated he could hear screaming outside his house. He stated he "decided I was going to die" and took 4 Paracetamol and 4 Simvastatin tablets which had been left in the house by his ex-girlfriend. Leon also took his prescribed medication which he had crushed and mixed with a cup of coffee (states this makes them work better). Leon then contacted the Samaritans and Richmond Fellowship and informed them of his actions. An ambulance was called and Leon was taken to A&E. Prior to taking the tablets Leon had contacted Haldane House and told the Secretary he was feeling unwell, contact from the West Fife Community Outreach Team had been arranged for later that day. No note had been left and there was no evidence of any final acts. Leon stated he knew what he had taken would not be fatal.

General Psychiatric and Medical History.

Previously well documented.

Current / recent medication

- Flupenthixol Decanoate 100mgs weekly.
- Nitrazepam.
- Diazepam.
- Chlorpromazine.

Full family history

Previously well documented.

Full personal history

Previously well documented.

Social circumstances

- Currently lives alone, recently split up with his partner.
- Describes a turbulent relationship with his mum.
- Extensive community support package in place.
- Currently in the process of having some poetry published.

Alcohol and Drug history

- Denies recent drug use.
- States occasional alcohol use. Stated he had a couple of drinks recently at his mum's wedding.
- Drinks around 9 or 10 cups of coffee a day.
- Uses "energy" drinks.

Forensic history

States only contact with Police is when he phones them due to concerns relating to his and other people's safety.

Mental state examination

- **Appearance and behaviour**
Slightly dishevelled and unkempt. Was listening to music and reading a book when I attended A&E. Good eye contact. Happy to engage with the assessment.
- **Mood**
Subjectively "very depressed". "Fed up with how my mum treats me". Objectively, euthymic, reactive.
- **Appetite**
"Eating fine", had something to eat before coming to hospital.
- **Concentration**
Fine, enjoys reading and writing poetry.
- **Sleep**
"Terrible". Described having turned night into day. Usually sleeps for about 3 hours then after so long sleeps for 24 hours to "catch up".

Mental State Examination cont'd

- **Speech**

Fluent, spontaneous and animated when discussing books and his poetry.

- **Thoughts**

States he sometimes thinks he can hear other people's thoughts. Describes being paranoid about people coming after him and trying to break into house.

- **Perceptions**

Hears voices "on and off". No objective evidence to suggest Leon was experiencing voices during assessment. Described "flashbacks" to being molested and raped.

- **Cognition**

Intact.

- **Insight and risk**

States he is no risk to others. Perceives himself to be at risk from intruders. Feels he could be a risk to himself if troubled by increasing perceptual disturbances. Feels he needs his medication reviewed.

Assessment of on going suicidal ideation or intent.

No evidence of ongoing suicidal ideation or intent.

Potential for positive risk taking

- Identified he had Aspirin at home but intended to "flush them down the toilet".
- Stated he would use prn Chlorpromazine to help with paranoid thoughts and voices.

Clinical Impression / Formulation

34 year old man with a diagnosis of schizophrenia and borderline personality disorder. Impulsive overdose secondary to perceptual disturbance. Recent social stressors include his mum's wedding and relationship break-up. No objective evidence to suggest deterioration in his mental state however as this is the second time Leon has been seen recently and urgent out-patient appointment is to be arranged.

Management plan

- Discussed with West five Community Outreach Team both prior to and following assessment.
- Discharge home if medically fit.
- To be seen by Community Outreach Team at Carnegie Clinic on the 1 October 2009.
- Out-patient appointment to be arranged with Dr Paul Cavanagh.
- Continue with community support already in place.

I spoke to Leon on the telephone on the 28th August 2008. He complained of hearing "screaming" which was causing him distress. His sleep was also affected and he had generally not been feeling very well. He had missed his depot antipsychotic appointment claiming that he was lacking in energy and motivation. He had called Haldane House on four occasions today requesting to speak to a member of nursing staff.

He has agreed to attend the Depot Clinic on Tuesday 2nd September 2008 and I have given him a script for Chlorpromazine 25mg PRN up to twice a day to help tide him over with the hallucinations in the meantime. I have also arranged to review him in my clinic in the next few weeks and I will keep you informed of his progress.

History of presenting complaint

Leon described being lonely, depressed and suicidal for a long time. The day prior to discharged he began to feel low again and was experiencing suicidal thoughts but was dismissive of them.

On the day of admission he described feeling "tired and black". He went to a local shop and bought 16 X Paracetamol tablets. He then went home and took the tablets. He described panicking and phoned the Samaritans. His father phoned for an ambulance who brought him to the A&E Department. He described "hoping to die" and "thought it would work". Prior to buying the Paracetamols he had no plans to commit suicide. He left no suicidal note and there were no plans in place if he died. Following his overdose he still said that he wanted to die but had no specific plans or intentions. He described his mood as depressed and his sleep up and down. He was able to spend time reading and writing which he had enjoyed up to a few days ago. He felt that he had little self worth and described himself as a "scum bag". He denied any homicidal ideation or psychotic symptoms. On the day of admission he had not consumed any alcohol or illicit substances.

Past psychiatric history

Mr Gratton has been well known to Psychiatric Services for a number of years with a diagnosis of schizophrenia and borderline personality disorder.

Family psychiatric history

He has an aunt who suffers from agoraphobia.

Past medical history

Eczema and asthma.

Personal history

He was born in Manchester and brought up in Fife. His parents separated when he was three years old. His childhood was uneventful until the age of 13, when his mother divulged that he and his sister had been sexually abused during childhood by their father. This caused a family row with the mother and son being ostracised from the family. She shared the full details of her allegation with Leon who became very disturbed and preoccupied with the whole issue. He spent the age of 15 to 16 in children's homes and left school at 15 with no qualifications and poor exam results. At the time he was taking drugs for much of the time. He has a patchy employment record and has had several jobs after leaving the school. He is currently unemployed. He was married once but is now divorced and has a 9 year old son from that relationship.

Social history

He currently lives alone in a council house in Inverkeithing. His last place of employment was with Asda's six years ago. He has financial support receiving DLA and Income Support. He smokes 20 cigarettes a day. He has a history of alcohol excess which is documented; however he denied any current alcohol consumption. He has a history of substance misuse. He has previously tried cannabis, amphetamines, cocaine and LSD. He has a forensic history of shop lifting and assault.

Mental state examination

He was casually dressed with good eye contact and was responsive. There were no abnormal movements and there was no reduced expression in his face. His speech was monotonous but normal in rhythm, rate but reduced in volume. There was no formal thought disorder. His mood subjectively was depressed and suicidal. Objectively he appeared low with reduced activity. His thought content was of suicide, feeling lonely and being depressed. He denied any perceptual abnormality and was not openly responding to hallucinations. Cognition was grossly intact. He was orientated to time, place and person (his insight was good, realising that he felt low in mood and willing to accept help and take medication).

Investigations

Urea and Electrolytes were normal. Abdomen was soft. Protein 76, Alkaline phosphatase 106, gamma-GT 93, ALT 49, bilirubin 5, Paracetamol 41.7 and salicylate 13.5 (both drug levels under treatment level). Full blood count and coagulation were normal.

Progress on the ward

Mr Gratton was admitted for further assessment of his mental state and suicidal ideation. He described taking the Paracetamol as two days prior to the overdose he had heard that charges against his father for sexually abusing him and his son were dropped. He described ruminating about this and another instance of rape. He described feeling like he had enough and he did not want to live.

Admission in the ward continued with suicidal ideation. At times there were reports of him laughing to himself, being overly animated and talking about the Mafia. The only expansion on this topic is that he felt that the kids at school were Mafiosa. He also described hearing screaming – “what I hear is screaming – it’s like someone is getting attacked”. There is always a female voice in the distance.

He had a weekend pass during his admission which he found difficult due to auditory hallucinations of laughter and therefore took extra Flupenthixol tablets with the purpose of stopping the voices. He felt that this helped. His depot was increased to 150 mgs weekly. He had some further passes where he felt more settled.

On discharge he had no further auditory hallucinations, paranoia or suicidal ideation. He was discharged with daily dispensing and is due to attend the Depot Clinic. Follow up includes WFCOT and Richmond Fellowship.

Dear Dr Somerville

This 33-year-old man, with known paranoid schizophrenia, was referred by the Community Mental Health Team, as he was expressing suicidal ideation in the form of an overdose of Valium, Paracetamol, slimming tablets and bleach.

History of presenting complaint

Leon was described as being unwell for the last 6-8 weeks. He had been more anxious and frightened in his flat at night-time. He complained of hearing voices at times, usually many different voices, which had increased in intensity in the last 1-2 weeks. The voices were telling him that he was a dog and "deranged species". He was also complaining of less sleep in the last 4-6 weeks, as he was paranoid and frightened at night-time. As a consequence, he had been sleeping more during the day. He felt his neighbours were very noisy and that they were being aggressive towards him. He told the community team that he felt like killing his neighbour today. He called the community team twice, threatened to take an overdose of Diazepam, Paracetamol, slimming tablets and bleach but denies having taken anything of yet. He also complained of poor appetite and weight loss.

Past psychiatric history

It is well described in previous letters. He has a diagnosis of paranoid schizophrenia and borderline personality disorder.

Family history

There is no history of mental illness in the family.

Past medical history

Eczema and asthma.

Current medication

Flupenthixol 100mg weekly.

Personal history

Well documented in previous letters. Born in Manchester, moved to Edinburgh when he was 2.

Social history

Currently lives alone, has support from Richmond Fellowship and WFCOT. Unemployed. Finances – gets DLA and Income Support. He is single, has one child with which he has no contact. He is a smoker and drinks occasional alcohol.

Mental state examination

He was slightly unkempt and unshaven. He had good eye contact and normal speech. There was no evidence of psychomotor agitation or retardation. His mood subjectively was low, objectively appeared slightly low with reactive affect. His thoughts were of suicidal ideation and he described wanting to take an overdose and thinking about killing his neighbour because he thinks he is a dog. He complains of voices at night mainly but no objective evidence of responding to external stimuli. No evidence of formal thought disorder. He was orientated to time, place and person and displayed little insight to his current circumstances.

Impression

Leon appeared to become less well in the last 6-8 weeks, displaying paranoid delusions along with suicidal ideation.

Progress on the ward

During his stay he talked about increased social stressors, in particular allegations of possible sexual abuse against his grandson from another member of the family. He had had his depot increased 2 weeks prior and did feel that this had begun to give him some benefit. Over the next 3 or 4 days the intensity of the voices reduced and he did not feel as distressed by their comments, which could be derogatory towards him. He felt that the voices would sometimes recede, particularly when he was distracted. His suicidal ideation also began to settle and, although he still had these thoughts every so often (which have been long-standing), he had no plans to harm himself and did not feel that he would act on his thoughts. On the day of discharge these were at a minimum and he described his son as being a factor in stopping him carrying out acts of self-harm. By discharge he no longer had any homicidal ideation and felt that, if the neighbours disturbed him, he would call the police. He was discharged home with follow-up with Richmond Fellowship, West Fife Community Outreach Team and Dr Cavanagh.

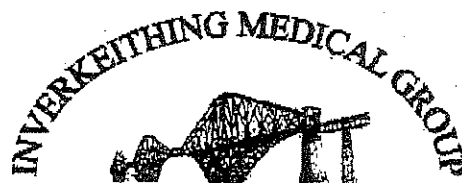
Leon first disclosed his abuse when he was a teenager and had counselling through the Edinburgh Child and Adolescent Services at that time. I think it unlikely that Leon would raise things that he has not had the opportunity to address in the past. As a general rule, we would like to keep abuse counselling separate to mainstream provision, as issues raised can become entangled with other aspects of the Care Plan to the detriment of working relationships, so in that respect, seeking counselling through an agency such as Safe Space would be a reasonably approach. I think however it would be very important that the counsellor involved was experienced and well supervised, as working with Leon may well present boundary issues.
